BELLSOUTH TELECOMMUNICATIONS, INC'S MOTION FOR EXTENSION OF DURATION OF ORDER GRANTING CONFIDENTIAL CLASSIFICATION

COMES NOW, BellSouth Telecommunications, Inc., ("BellSouth"), pursuant to Rule 25-22.006, Florida Administrative Code, and files its Motion for Extension of Duration of Order Granting Confidential Classification, and states as grounds in support thereof the following:

1. On August 21, 1997, BellSouth filed a Request for Confidential Classification in response to Staff's Subpoena Duces Tecum for the production of certain information. This information details the quantity and types of services purchased from BellSouth by ALECs. Also, the information includes, in some cases, the termination location of these services. Commission assigned Document Nos. 08478-97 and 07738-97 to this proprietary information.

2. By Order issued September 2, 1997, the Florida Public Service Commission ("Commission") granted BellSouth's Request for Confidential Classification of the customer specific information.

3. The information requested remains in the possession of Staff.

4. The reasons BellSouth asserted in support of confidential treatment in its original motion continue to pertain. Specifically, there is still a need to protect customer specific information.

5. For the reasons set forth above, and in the original Request for Confidential Classification filed on August 21, 1997, BellSouth hereby requests that this Commission enter an Order extending the period of confidential classification for an additional 18 months, or for any longer period of time that the documents remain within the possession of Staff.

WHEREFORE, for the reasons set forth above, BellSouth respectfully requests the entry of an Order extending the period of confidential classification as described above.
