PaeTec is providing the following information as "Year 2000 Readiness Disclosures." The disclosures made herein are "Year 2000 Readiness Disclosures" as defined by the Year 2000 Information and Readiness Disclosure Act of 1998.

PaeTec understands customer concern about the Year 2000 issue. In response to this concern, PaeTec has undertaken a review of its information technology and operating systems. PaeTec also has ensured that vendors supplying PaeTec with the custom built applications and related functions necessary to provide consistently outstanding telecommunications service have guaranteed their products as Year 2000 compliant or subject to corrective action to make such products Year 2000 compliant by December 31, 1999.

ACK Outside vendors providing statements to PaeTec concerning Year 2000 compliance include Elliott MagneTek Power Systems, Liebert, Alcatel Network Systems, Inc., Cutler-Hammer Automatic Transfer Switches, Electronic Tele-Communications, Inc., Illuminet, Daleen Technologies, Inc. and Lucent Technologies.

> PaeTec certifies that all of (i) PaeTec's internal systems that are material to the business or operations of PaeTec including, without limitation, computer hardware systems, software applications, firmware, equipment containing embedded microchips and other embedded systems, and (ii) the software, hardware, firmware and other technology that constitute part of the products and services marketed, provided or sold by PaeTec are Year 2000 ready and will not be adversely affected with respect to functionality,
