To Whom it may concern:

It is with the utmost of humility and embarrassment that I write this letter to you today. The attached documents reflect a proposed cancellation by the Florida Public Service Commission of my Pay Telephone Certificate #5520. The purpose of my writing today is to briefly explain why it happened, to submit all current and past documentation and assessments due, and to humbly ask for my license not to be canceled.

- 12/5-12/31/97 Regulatory Assessment Fee- I received my license in December 1997 but did not place phones at locations until 1998. Being new to the business, I did not realize that a \$50 minimum fee had to be paid regardless of having \$0 revenues to report. Attached please find the 1997 Assessment Fee Return with a check for \$69.50 (\$50 plus penalty and interest).
- 2. 1998 Regulatory Assessment Form- I do not recall ever getting it. Having never filled one out before, it was not something I was looking for either. The reality is that I should have know however and followed up to get a copy. I did not. I have enclosed a copy of 1997's with 1998's information on it. I have also attached a separate check for \$49.34 which covers the assessment plus interest and late payment.
