As per our telephone conversation on March 1, 1999, I am requesting your assistance in opening a **Basic Change Deck** as soon as the order is effective.

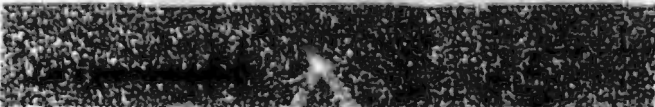

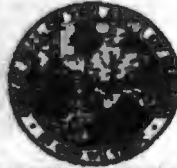
