ORDER APPROVING SETTLEMENT

BY THE COMMISSION:

Tel Con Resources, Inc. (Tel Con) currently holds Certificate of Public Convenience and Necessity No. 3036 issued by the Commission on April 21, 1992, authorizing the provision of pay telephone service. The Division of Administration advised our staff by memorandum that Tel Con had not paid the regulatory assessment fees (RAFs) required by Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code, for the year 1997, nor statutory penalties and interest charges for late RAF payments for the year 1997.

Under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAF of \$50 if the certificate was active during any portion of the calendar year. Pursuant to Rule 25-4.0161(2), Florida Administrative Code, the form and applicable fees are due to the Florida Public Service Commission by January 10 of the subsequent year. All entities that apply for certification receive a copy of our rules governing pay telephone service and an affidavit in which the applicants attest that the rules have been received and understood by the applicant. This affidavit must be attached to the application in order for the application to be processed. The RAF form was mailed to Tel Con for the period of
