Statement of Financial, Managerial, and Technical Capability

YourTel Telecom Corporation ("YourTel" or the "Company") is a start-up alternative local exchange carrier in the business planning phase. Florida is one of four initial states that YourTel intends to enter. In Florida, YourTel intends to initiate service in the Tampa metropolitan area. YourTel will serve both residential and business subscribers. YourTel will offer a full range of local exchange services, as well as innovative new services and features, at rates significantly below those of the incumbent local exchange carrier in the geographic areas YourTel serves.

The attached financial statements reflect the capitalization of YourTel Telecom Corporation and a *pro forma* projection of revenues and earnings for the next three years. The Company currently is capitalized with \$1 million in seed equity provided by senior management and members of YourTel's Board of Directors. By October 1999, YourTel intends to raise \$50 million in equity from private capital sources, including \$5 million in short-term implementation funding, and \$50 million in vendor financing. YourTel is in active discussions with venture capital funds, financial institutions, and individual investors with respect to its initial capital requirements. With respect to the vendor financing, the Company also is in detailed discussions with several major telecommunications equipment vendors and their financing partners.

Following completion of the initial financing round, YourTel intends to raise a total of \$630 million in additional resources through various financial instruments and transactions.

Attached is biographical information on the senior managers and board members of YourTel Telecom Corporation. Albert Halprin, former Chief of the Federal Communications Commission's Common Carrier Bureau, is Chairman of YourTel. Jeffrey J. Milton is President and Chief Executive Officer of YourTel. Gregory K. Kapfer is Chief Financial Officer, Norbert Snobeck is Senior Vice President and Chief Technology Officer, Kevin McGilly is Vice President – Regulatory and External Affairs, and Linda Klieforth is Vice President – Human Resources and Administration. Individually and collectively, the senior managers and directors of YourTel have vast experience and expertise in all aspects of telecommunications service provision. In the start-up phase, they are YourTel's primary asset.

YourTel has not yet identified the specific exchanges within Florida in which it intends to offer services, nor has YourTel defined the precise service offerings and pricing for its services. Once certified as an ALEC, and pursuant to the Commission's rules, YourTel will submit a price list including all required information prior to beginning to offer service in Florida.
