AMENDMENT TO PETITION

Northeast Florida Telephone Company, Inc. ("Northeast" or the "Company") hereby amends its Petition, filed in this docket on May 10, 1999 ("Petition"), by deleting paragraph 11 (g) of the Petition, relating to cost recovery, without prejudice. If and when Northeast pursues recovery of the costs of implementing IntraLATA Toll Dialing Parity, it will do so by filing a tariff that recovers the relevant costs in a competitively neutral as contemplated in the Telecommunications Act of 1996 and the relevant FCC orders.

WHEREFORE, Northeast requests that the FPSC issue an Order approving Northeast's Petition as amended herein.
