The Commission Staff has brought to AquaScurce Utility, Inc.'s attention, as purchaser of the assets of Rotonda West Utility Corporation, the apparent overlap between its water and wastewater service area and the water service area of Fiveland Investments, Inc., now owned by Charlotte County, and the wastewater service area of Sandalhaven Utility, Inc.

We have discussed this matter with Richard Howell, the Director of Charlotte County Utilities, and otherwise reviewed the situation. In the spirit of cooperation with Charlotte County, AquaSource Utility, Inc. hereby agrees that the description of the service area it is acquiring in connection with its purchase of the assets of Rotonda West Utility Corporation, exclude that portion of its service area in the northwest quarter of Section 3 of Township 42 South, Range 20 East which overlaps with the service areas of the aforementioned utilities. It is my understanding that Pat Brady has the more specific legal description.
