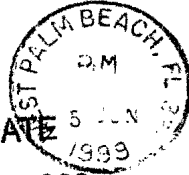

The Commission received the note from this company on April 19, 1999, which stated that Mr. Gulino had passed away and that the company was sold in July 1998. Commission rules provide that if a certificate is active for any day during a calendar year, regulatory assessment fees (RAFs) are owed for the year. According to the Commission's Division of Administration's records, the 1998 RAFs were due by February 1, 1999, and as of this date, we do not show receipt of payment. I can make the effective date of the cancellation July 31, 1998 so that you will not owe the 1999 RAFs. Details of the past due charges are provided below:

1991	-0-	\$2.50	\$.50	The RAF was paid on 2/18/92 but the penalty and interest was not paid.
1995	-0-	\$1.25	\$.25	The RAF was paid on 1/31/96 but the penalty and interest was not paid.
1998	\$50.00	\$10.00	\$2.00	Payment was due 2/1/99. No payment was received. Payment must be postmarked by 5/31/99 to avoid an increase in the penalty & interest charge.

The past due amount of \$66.50 must be paid in full before the certificate can be voluntarily canceled. If the 1998 RAF payment is mailed in June 1999, the total amount increases to \$69.50 since the penalty and interest increase each month. Payment should be mailed to:
