A copy of your 1998 regulatory assessment fee (RAF) form was recently forwarded to me for follow up since the name of the company on the form had the "d/b/a FTI Communications" marked through, leaving only the corporation name. I checked the Department of State, Division of Corporations' (DOS) records and found that the name "I-Link Communications, Inc." is registered and an active corporation.

What this means is that the name on your certificate could be changed administratively if that is what you wish. ORDER ACKNOWLEDGING NAME CHANGE

BY THE COMMISSION:

By letter dated October 3, 1997, Family Telecommunications Incorporated d/b/a FTI Communications and d/b/a WealthCom (Family Telecommunications), holder of Interexchange Telecommunications Certificate of Public Convenience and Necessity Number 4778, requested that Certificate Number 4778 be amended to reflect the new corporate name, I-Link Communications, Inc. d/b/a FTI Communications (I-Link). Upon review of the Department of State, Division of Corporations' records, it appears that Family Telecommunications has properly registered the new corporate name. Accordingly, we find it appropriate to amend Certificate Number 4778 to reflect the new operating name.

This Order will serve as the amended Interexchange Telecommunications Certificate of Public Convenience and Necessity Number 4778 for I-Link. I-Link should retain this Order as evidence of the name change.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the request by Family Telecommunications Incorporated d/b/a FTI Communications and d/b/a WealthCom to change the name on Certificate Number 4778 from Family Telecommunications Incorporated d/b/a FTI Communications and d/b/a WealthCom to I-Link Communications, Inc. d/b/a FTI Communications is hereby approved. It is further

ORDERED that this Order will serve as I-Link Communications, Inc. d/b/a FTI Communications's amended certificate and that this Order should be retained as evidence of the name change. It is further

ORDERED that this change will be effective ten (10) days from the issuance of this Order. It is further
