Ms. Bayo, I am writing you this letter on behalf of our members who have signed the attached petition to accept the settlement offer proposed by Florida Water.

We feel it is a reasonable offer that will end the current litigation that has been ongoing since 1995. We are against the idea of surcharges on customers bills. If water bills are mailed to customers with the aggravating surcharge on it, there must be an accompanying explanation for the charge. The explanation will create unnecessary criticism and complaints to Florida Water and the Florida Public Service Commission about something that will not be changed once implemented. Any explanation of a surcharge, is also highly unlikely to satisfy the customer.

Please consider our request for the Florida Public Service Commission to accept the settlement offer.

We, the customers of Florida Water Services served by the <u>Deltona</u> plant, petition the Florida Public Service Commission to accept the settlement offer proposed by Florida Water, which includes a three-year agreement not to file a new rate case, calls for the treatment of surcharges as an investment in the next rate case, and increases rates prospectively at 1.7 per cent, one half of the potential liability from the appellate court reversal. Surcharges create a severe hardship for our customers, and further litigation expenses are only included in future customer rates. We would like to see these rate issues involved in the 1995 rate case finally settled, once and for all.
