BY THE COMMISSION:

NOTICE IS HEREBY GIVEN by the Florida Public Service Commission that the action discussed herein is preliminary in nature and will become final unless a person whose interests are substantially affected files a petition for a formal proceeding, pursuant to Rule 25-22.029, Florida Administrative Code.

Section 364.33, Florida Statutes, provides that a person may not acquire ownership or control of any telecommunications facility, or any extension thereof for the purpose of providing telecommunications services to the public, including the acquisition, transfer, or assignment of majority organizational control or controlling stock ownership, without prior approval from this Commission.

By letter dated March 18, 1998, IDT Corporation (IDT) and IDT America Corp. (IDT America) jointly requested approval of IDT's proforma corporate reorganization and assignment of its Interexchange Telecommunications (IXC) Certificate No. 3581 to its wholly-owned subsidiary, IDT America. IDT has stated that the transactions will be virtually transparent to its customers.

We determine that IDT has met the requirements of Section 364.33, Florida Statutes. Accordingly, we find that the reorganization is in the public interest, and we approve it pursuant to Section 364.33, Florida Statutes.

IDT and IDT America have complied with Rule 25-24.473, Florida Administrative Code, regarding the assignment of IXC certificates. We find the assignment to be in the public interest and, therefore, approve the assignment. IXC Certificate No. 3581 shall be amended to reflect that IDT America is the holder of this certificate.
