Lupton Industries (Lupton) currently holds Certificate of Public Convenience and Necessity No. 2406, issued by this Commission on November 14, 1989, authorizing the provision of pay telephone service. On January 5, 1999, Lupton filed a 1998 regulatory assessment fee return, reporting gross intrastate revenues of \$1,359.25 and one pay telephone in operation.
