Dear Mr. Brown:

We received your e-mail of April 29, which advised that you had terminated your pay telephones and wished to cancel your certificate. Ms. Nancy Pruitt responded by e-mail on April 30 and advised that if your check was postmarked in May, you would owe a total of \$112.00 (\$50.00 regulatory assessment fee for 1999 and \$62.00 for 1998). Ms. Pruitt sent another e-mail on May 10 and a follow up letter dated June 21, reminding you that payment of the regulatory assessment fee (RAF) was due before your certificate could be canceled. The Commission's Division of Administration recently notified us that you paid \$112.00 on June 25, 1999 (the postmark date of your envelope).

Unfortunately, we still cannot recommend to the Commission that your certificate be canceled with an outstanding balance, even with such a small balance as \$9.00. The Division of Administration records show that you have a \$3.00 penalty and interest balance from 1994 RAF (you paid on February 16, 1995 -- payment was due January 30, 1995), \$3.00 penalty and interest balance from 1995 RAF (you paid on August 15, 1995 -- payment was due July 30, 1995), and a \$3.00 penalty and interest balance from 1998 (the penalty for paying in June was \$12.50 -- you paid \$12.00 and the interest was \$2.50).

Please send a check for the \$9.00 balance. As soon as it is received, we can open a docket to cancel your certificate. If you have any questions, just let me know. I can be reached at (850) 413-6502-voice, (850) 413-6503-fax, and by internet e-mail at pisler@psc.state.fl.us.

I was given your Internet request that your payphone certificate be canceled. I have unsuccessfully tried to contact you by Internet to let you know that your certificate cannot be voluntarily canceled until all outstanding regulatory assessment fees and penalties and interest are paid.

You did not pay your 1998 fee of \$50.00. If payment is received in June the statutory penalty is \$12.50 and the interest is \$2.50 for a total of \$65.00. If payment is made in July the penalty is \$12.50 and the interest is \$3.00 for a total of \$65.50.
