## SECOND SUPPLEMENTAL REQUEST FOR CONFIDENTIAL CLASSIFICATION

Florida Power Corporation (Florida Power or the Company) hereby supplements its request for confidential classification filed jointly with El Paso Power Services Company (El Paso) on June 4, 1999 and, pursuant to Section 366.093, F.S., and Rule 25-22.006, F.A.C., requests confidential classification of designated portions of First Amendment to the Master Agreement to Amend and Restate Contracts for the Purchase of Firm Capacity and Energy Between Florida Power and El Paso (the Amendment). The confidential information subject to this second supplemental request has been highlighted in transparent ink on the Amendment, which has been placed in a separate, attached envelope marked "Confidential" and should be given confidential treatment pending the disposition of this request.

The original request for confidential classification filed on June 4, 1999 sought confidential treatment for designated portions of the exhibits to the above-captioned Petition. Among these was Exhibit 1, the agreement between Florida Power and El Paso which has now been modified in certain limited respects by the Amendment DOCUMENT NUMBER-DATE

which is the subject of this second supplemental request. The Amendment recites and in some cases amends information from Exhibit 1 for which confidential classification was sought by the original June 4, 1999 request. This second supplemental request seeks to maintain the confidentiality of this restated and amended information contained in the Amendment. Specifically, this confidential information is contained in Section 5 of the Amendment and in revised Exhibits A and H attached to the Amendment, and has been highlighted accordingly. The justification for confidential treatment of this information contained in the original request applies equally to this second supplemental request and is incorporated herein by this reference.

WHEREFORE, Florida Power Corporation respectfully asks that the original request for confidential classification filed on June 4, 1999 be supplemented by this request and that the highlighted information in the attached Amendment be classified as confidential.
