On February 19, 1998, the Utility (water system) entered into a Consent Order with Florida Department of Health, Polk County, for failure to monitor for Primary Inorganics, Secondaries, Volatile Organic, Pesticides, PCB's, Radiological and Group II Unregulated Contaminants in 1997. The system also failed to do Public Notification.

A contract has been signed with Shaw Construction and Management Services, Inc. to upgrade the WWTP to 240,000 GPD. The contract amount is for \$284,500 and excludes a number of upgrade items.

Construction began in July of 1999 and should be completed by February of 2000. According to the "Preliminary Design Report" prepared by Michael Gaylor, P.E., the 240,000 GPD WWTP will handle the build out of the 1557 lots and clubhouse.

It is Utilities, Inc.'s goal, in any negotiated arms length transaction, to purchase at the lowest possible price. The factors considered by Utilities, Inc. in negotiating the purchase of the Cypress Lakes system were some of the same factors considered in all negotiated purchases. These factors include the long-term earnings potential of the utility, the potential growth of the customer base, the overall regulatory climate where the utility is located, the current and future capital needs of the utility and the ability to recover additional costs on a timely basis, and proximity to other Utilities, Inc. operations.

The factors listed above are considered in light of the specific circumstances of the proposed transaction and the perceived value to the seller.
