BY THE COMMISSION:

John Kenefick d/b/a Telpro (Telpro), holder of Pay Telephone Certificate (PATS) of Public Convenience and Necessity No. 2878, has requested the cancellation of PATS Certificate No. 2878. Telpro has complied with the provision of Rule 25-24.514(2), Florida Administrative Code, by providing adequate notice in writing of its request for cancellation of its PATS certificate and by submitting its regulatory assessment fees (RAFs) for 1998. Accordingly, we find it appropriate to cancel PATS Certificate No. 2878, effective August 1, 1999.

Telpro shall return its certificate to this Commission. In addition, under Section 364.336, Florida Statutes, certificate holders must pay a minimum annual Regulatory Assessment Fee of \$50 if the certificate was active during any portion of the calendar year. This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
