1. Concurrent with the filing of this notice, ITC^DeltaCom will file its supplemental responses to Staff's First Request for Production of Documents. ITC^DeltaCom intends to file a request for confidential classification of the documents produced in response to Staff's document request numbers 2(a) and 11:


- a. Region wide data by state showing the provisioning/ordering intervals for ITC^DeltaCom resale orders, produced in response to Staff document request 2(a), and


