Gulf contends that the witnesses' unavailability will prevent them from completing their review and preparation for filing their rebuttal testimony by October 29, 1999. In its motion, Gulf states that no party to this docket opposes this request. Because Gulf has shown good cause for the requested extension and no party opposes the motion, Gulf's request is hereby granted.

By motion filed October 22, 1999, Tampa Electric Company (TECO) requests a similar extension of time to file its rebuttal testimony in this docket. TECO's request applies only to its rebuttal testimony concerning the testimony filed by Mr. Kent Taylor on behalf of the Florida Industrial Power Users Group (FIPUG). In its motion, TECO states that FIPUG does not oppose this motion. In light of the extension granted to Gulf and the lack of opposition to the motion, TECO's request is hereby granted.

Good cause having been shown, it is therefore

ORDERED by Commissioner Susan F. Clark, as Prehearing Officer, that Gulf Power Company's Motion for Extension of Time is hereby granted. It is further

ORDERED that Tampa Electric Company's Motion for Extension of Time is hereby granted.
