The FPSC's Compliance with the FCC's Geographic Deaveraging Rule 51.507(f)

- I. Introduction: The FPSC expects to be in compliance with FCC's Rule 51.507(f) within the six months provided for in the FCC's Stay order. (Walter D'Haeseleer)
- II. Key Decisions (Donna Clemons/Sue Ollila):
  - a) Since expedited time frames are required, is it possible procedurally to conduct formal or informal parallel proceedings, with identical time lines, without contaminating the existing Phase I? Or must certain events (and if so, which ones) be staggered so they occur after decisions have been made in Phase I (e.g., can separate proceedings begin before the Phase I hearing scheduled for December 15-17, 1999)?
  - b) Should, or must, any interim rates be subject to true-up?
- III. Assuming the FCC's Order on the 319 remand requires that only loops be deaveraged, staff would like to discuss the feasibility of the following options (Walter D'Haeseleer/Sue Ollila/Donna Clemons):
  - a) Parties stipulate to a set of agreed-upon interim geographically deaveraged loop rates.

OR

b) A separate proceeding runs concurrent with/subsequent to Phase I of 990649 where the FPSC staff proposes interim geographically deaveraged loop rates based, e.g., on the cost proxy model results from 980696. Parties to file direct and rebuttal testimony on proposed rates. Expedited time frame includes hearing.

- c) Separate proceeding concurrent with/subsequent to Phase I of 990649 where the parties propose interim geographically deaveraged loop rates. Parties file direct and rebuttal testimony. Expedited time frame includes hearing.
- IV. Assuming the FCC's Order on the 319 remand requires UNEs in addition to loops to be deaveraged, staff would like to discuss the feasibility of the following options (Walter D'Haeseleer/Sue Ollila/Donna Clemons):
  - a) Parties stipulate to (some or all) interim geographically deaveraged rates for the required UNEs.
