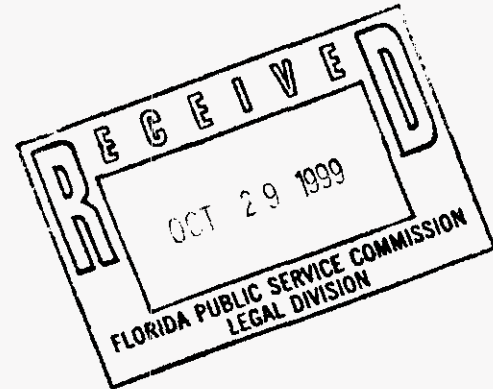

This letter will confirm our conversation this morning regarding the Seventh Revised CASR issued in the above-referenced dockets which shows that intervenor and staff prefiled testimony is due November 12, 1999. As we discussed, Florida Water Services Corporation ("Florida Water") is an intervenor in Docket No. 970657-WS and the company applicant in Docket No. 980261-WS. You advised that it was staff's intention to allow Florida Water to file testimony on November 12, 1999 in either Florida Water's capacity as an intervenor or Florida Water's capacity as a company applicant which addresses additional issues which have arisen following the issuance of the December 23, 1998 Prehearing Order, including but not limited to issues arising out of the purchase of Lake Suzy Utilities, Inc. by Aqua Source Utility, Inc.
