Dear Ms. Bayo:

In accordance with Chapter 25-6.018 of the Florida Administrative Code, I am submitting a report on the interruptions of Florida Power & Light (FPL) Company's Commercial/Industrial Load Control (CILC), Interruptible Standby and Supplemental (ISST), and Curtailable (CS) customers' load. The report is given in four attachments.

Attachment I provides a list of CILC and ISST customers interrupted system wide on April 6, 1999 in order to offset heavy power demands and a capacity shortage resulting from hot weather. The control period was as follows:
