

Dear Tommy:

To follow up on our conversation yesterday, this letter describes the steps I will take on behalf of American Telcom, Inc., d/b/a FoneTel ("FoneTel") and Long Distance of Michigan, Inc., d/b/a LDMI Long Distance ("LDMI"), in the context of Florida operating authority and associated tariffs, to properly transition the relevant FoneTel assets to LDMI.

To summarize, on February 8, 1999, Fone Tel filed voluntary petitions under Chapter 11 of the United States Bankruptcy Court for the Eastern District of Michigan. Fone Tel subsequently filed a motion for the Bankruptcy Court's approval of the sale of certain assets to LDMI under an Asset Purchase Agreement ("Agreement") as the best way to maximize creditor recoveries and preserve uninterrupted service to their customers. Under the Agreement LDMI will acquire at closing various Fone Tel assets, including the name, customer accounts, and Carrier Identification Code (CIC). On April 9, 1999, the Bankruptcy Court approved Fone Tel's motion and authorized and directed Fone Tel to sell its assets to LDMI as provided in the Agreement (Exhibit A). On or around July 9, 1999, the Conversion Period will end thereby transferring the ongoing operation and maintenance of the subject assets to LDMI. LDMI will provide service to Fone Tel's customers under the same rates, terms, and conditions as currently provided for in Fone Tel's tariffs and contracts. LDMI plans to provide a seamless transition for existing Fone Tel customers.

To that end, based on our conversation yesterday, FoneTel customers will continue to be served under FoneTel's operating authority and associated tariff in Florida until LDMI adds the "FoneTel" d/b/a, as well as the current intrastate FoneTel products, to the LDMI Florida tariff. This filing will occur once the conversion period closes and the necessary documentation can be processed with the Secretary of State. At that time we will request that FoneTel's operating authority and tariff be withdrawn.
