Dear Chairman Garcia:

Earlier today I filed a Notice of Substitution of Counsel in the above-referenced docket. My firm will be representing Palm Coast Utility Corporation ("Palm Coast") in the remand stage of this proceeding.

The staff has filed a November 18, 1999 recommendation addressing specific issues appealed by Palm Coast and reversed by the First District Court of Appeal for further disposition on remand by the Commission. Obviously, having just gotten involved in this case, I will need a reasonable amount of time to familiarize myself with the underlying record and the appeal prior to addressing the issues on remand. In addition, a preliminary review of the staff recommendation and attached schedules by Florida Water Services Corporation, who recently purchased the assets of the Palm Coast Utility Corporation system, indicates the need to secure copies of staff's working papers used to compile the numbers reflected in the text and schedules of the November 18 recommendation. We will be filing a public records request early next week to that effect. Again, additional time to analyze the work papers, staff's calculations and the numbers in the recommendation will be necessary prior to addressing the Commission in the initial phase of this remand proceeding. With the holidays ahead of us, we expect it will be extremely difficult to accomplish this even prior to the next Agenda Conference in December.
