ORDER APPROVING SETTLEMENT

BY THE COMMISSION:

Major Communications Consulting, Inc. (Major Communications) currently holds Certificate of Public Convenience and Necessity No. 4590, issued by the Commission on April 20, 1996, authorizing the provision of Pay Telephone service. The Division of Administration advised our staff by memorandum that Major Communications had not paid the 1998 Regulatory Assessment Fees (RAFs). Also, accrued statutory penalties and interest charges for late RAFs payments for the year 1998 had not been paid. RAFs are required by Section 364.336, Florida Statutes, and Rule 25-4.0161, Florida Administrative Code.

All entities that apply for certification receive a copy of our rules governing Pay Telephone service. All applicants must attest that these rules have been received and understood by the applicant and an affidavit must be attached to the application in order for the application to be processed.

Pursuant to Section 364.336, Florida Statutes, certificate holders must pay a minimum annual RAF of \$50 if the certificate was active during any portion of the calendar year. The RAFs form was mailed to Major Communications for the period of January 1, 1998, through December 31, 1998, on December 10, 1998. Pursuant to Rule 25-4.0161(2), Florida Administrative Code, the form and applicable fees are due to the Florida Public Service Commission by January 30 of the subsequent year. However, pursuant to Section 350.113(4), Florida Statutes, the Commission shall provide at least 45 days prior notice of the date the payment is due. Major Communications was scheduled to remit its RAFs by February 1, 1999.

On September 27, 1999, Mr. Walter Jones, President of Major Communications, contacted our staff and asked that thee 1998 RAFs form be faxed to him, along with information on the disposition of this matter. At the October 5, 1999, Agenda Conference, we voted to cancel Major Communications's certificate unless it paid a \$500 fine and the past due fees. On this same date, we received from Major Communications the past due amount in full, a letter proposing to contribute \$100 to the State General Revenue Fund and to pay future RAFs in a timely basis, and a check in the amount of \$100 to satisfy the settlement contribution.

We believe that the terms of the settlement agreement represent a fair and reasonable resolution of this matter. Accordingly, we hereby accept the settlement offer. The contribution will be forwarded to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that Major Communications Consulting, Inc.'s settlement proposal summarized in the body of this Order is hereby approved. It is further

ORDERED that the contribution will be transmitted to the Comptroller for deposit in the State of Florida General Revenue Fund. It is further

ORDERED that this docket is closed.

Rule 9.900(a), Florida Rules of Appellate Procedure.
