Dear Mr. Williams:

After our phone conversation today, I feel compelled to write this letter to you. As you recall, you informed me of a name change that my company, Easy Phone, Inc., has gone through in order to reflect your records.

Apparently, certificate # 4773 from the Florida Public Service Commission had been issued to Easy Collular, Inc. d/b/a/ Tel Com Plus to offer pre-paid, non-facilities based residential services in the state of Florida. You have informed me that a new certificate # 4769 has been issued to Easy Phone, Inc. d/b/a/ Easy Tel to offer pre-paid, non-facilities based residential services in the state of Florida.

This tetter is to inform you of the sequence of events regarding certificate # 4773, Easy Cellular, Inc. d/b/a/ Tel Com Plus.

On or about December, 1997, Easy Cellular, Inc. (it was then changed to Easy Phone, Inc. d/b/a/ Easy Cellular, Inc.) entered into an agency agreement with Mr. Richard Pollara and Tel Com Plus. They were to lease our telecommunications license in the states of FL and CA to offer pre-paid residential service to credit challenged end users.

In, or around, September 1998, this agreement was cancelled and voided. At that time, Tel Com Plus was instructed to cease and desist any and all activity under our license (certificate # 4773) in FL. 1 was under the assumption they did. Obviously not.

I do not know anything about having a new certificate issued (#4769) nor am I receipt of any correspondence that your office had with MY company and me. If you look at all of your correspondence, you will see that any and all letters went to an address in Florida.

The reason this agency agreement was cancelled in the first place was that Mr. Pollara and Tel Com Plus did not pay the carrier invoices and therefore left them unpaid in Easy Cellular's name. I am currently involved in litigation with them regarding unpaid carrier invoices in the states of FL and CA for which Tel Com Plus obtained every single dime

for. Not only have they not paid carrier invoices, but telecommunications invoices and Federal Excise taxes, as well,

Mr. Pollara and Tel Com Plus had then migrated all Easy Cellular's end users on to his new license, U.S. Telecommunications. (Or so I thought).

Clearly, he is at it again. Changing the name of the company to Easy Yel and actting a new certificate # issued through the FL Public Service Commission to operate yet another CLEC for which he can receive all of the revenues but leave me holding the debt to the carriers.

LET IT BE KNOWN THAT EFFECTIVE TODAY, 7/22/99 CERTIFICATE # 4773 AND #4769 THAT ARE ISSUED TO EASY CELLULAR IN ANY FORM ARE TO BE CANCELLED IMMEDIATELY. CANCEL ALL CERTIFICATES. IF ANYONE IS CAUGHT USING THEM AFTER TODAY, YOU HAVE PERMISSION TO PROSECUTE TO THE FULL EXTENT OF THE LAW.
