MOTION FOR HEARING

COMES NOW THE PETIONER, THE COLONY BEACH & TENNIS RESORT, by and through its undersigned representative, and respectfully requests the Commission set this matter for hearing, and as grounds therefore would state:

- 1. Resolution of this matter is impractical outside an adjudication to determine the substantial interests of the Colony based on the disputed issues of fact and individual circumstances of this case.
- 2. The facts asserted by the Colony which give rise to the allegation of over-billing, and which are disputed by FP& include the following: a) that in January 1988 the Colony requested FP&L to assist it in helping reduce energy costs at the Colony by master metering the property and providing service on FP&L's lower rate generally used by other hotels in FP&L's service territory, 2) that FP&L refused such request by the Colony, 3) that at all times material to such request, the Colony held it self out as, operated as, was licensed as, and was legally a "hotel", 4) that the Colony currently holds itself as, is DOCUMENT NUMBER-DATE licensed as, and is by legal definition a "hotel".

FPSC-RECORDS/REPORTING

3. It cannot be determined whether or not the Colony fell within the expressly stated exception to the individual metering requirement of Rule 25-6.049(5)(a), where hotels, motels, and similar facilities are not required to be individually metered, until a factual determination is made as to the status of the Colony as a hotel. Nor can a violation of Rule 25-6.093(2) FAC or Section 366.03, Florida Statutes be determined without a factual determination of Colony's status as a hotel, and a factual determination of whether the Colony did in fact, request master metering by FP&L in 1988.

WHEREFORE, THE COLONY respectfully requests the Commission grant its motion for hearing in this matter.
