Audio Tape of Special Meeting, August 26, 1999, Buccaneer Homeowners' Association, at which proposed settlement agreement between OPC and NFMU was introduced.

- * Note; This meeting did not have a quorum. A quorum is obtained only after 51% or more of the owners of 971 homes are present; (Fs 723). 496 owners are needed for a quorum yet only 307 people were present. Vote is not legal as only 297 people voted for agreement; and even then the vote was calculated by subtracting abstainers and opposing voters from the total number of attendees rather than a count of actual supporting voters.
- * Intimidation was used by all supporting parties to obtain even the small vote of support. Dissension was not allowed, or should be a supported by the wastewater committee members in supporting their position. Please listen to at least the last two thirds of the ctappy at which time the agreement had been read out and homeowners were finally allowed to ask questions.

Proposed Settlement Agreement

This proposed settlement agreement is made and entered into by Ronald Ludington ("Ludington") on behalf of the homeowners of Buccaneer Estates; and, North Fort Myers Utility, Inc. ("NFMU").

Whereas; NFMU has filed an application ("application") with the Florida Public Service Commission ("PSC") to extend it waste water service area to include Buccaneer Estates Manufactured Home Community, ("Buccaneer"); and

Whereas Ludington has filed an objection to NFMU's application; and

Whereas the parties recognize the expense and uncertainty of this procedure, the parties now desire to settle their differences.

Now therefore it is agreed that in exchange for Ludington dismissing his objections to the application, and now even supporting the granting of the application, NFMU grants the following conditions shall be established between the parties.

- 1. Commencing with waste water service rendered on and after March 1, 1999, to Ludington and all other homeowners of Buccaneer, NFMU agrees to send its invoices for this service to the owners of Buccaneer, instead of the homeowners of Buccaneer, using a billing schedule known as approved Rate Schedule GS; and
- 2. NFMU agrees to drop its right to collect, now or in the future, any service availability fees, or any monthly fees that it mistakenly thought were to be collected through clauses in a faulty developers' agreement that it mistakenly signed with the park owners in 1998.
- 3. NFMU agrees that it has the right to obtain water meter readings necessary for this billing, and that Buccaneer Water Service ("BWS"), a PSC regulated company, may be forced to supply these readings by the PSC, if BWS resists doing so.
- 4. Ludington agrees that he will abide by these conditions as long as the PSC renders the adoption of them as being in the public interest, and that he will drop all other matters of objection he now has before the PSC in support of his rights.
- 5. NFMU agrees, now or in the future, not to affect the rights of Ludington or any other homeowner of Buccaneer in his, or their, pursuit of contract rights granted to them under Chapter 723, Florida Statutes.
- 6. Ludington agrees that the Order to Show Cause proceeding against NFMU should be dismissed without penalty.
- 7. Ludington acknowledges that NFMU is the sole owner of the waste water collection system in Buccaneer and will do nothing to dispute this fact as long as this agreement is in effect.
- 8. This Proposed Settlement Agreement was submitted for its approval, to the PSC panel at a hearing held on Oct. 13, 1999 (and will be offered to the PSC for adoption again on Nov. 16th, 1999.)

have tried, on at least 3 occasions, to give you your opportunity. If in the future you would like to speak to the EXAMINER, we will be more than happy to do this.

Another meeting was held on Wednesday, December 15, 1999, at 7 p.m. during which two of the three "mavericks" talked to residents about many of their findings while going through transcripts of the decision-making discussion that Public Service Commissioners held after the hearing in Tallahassee on November 16. In direct contrast to the meeting on Monday, this meeting was orderly and extremely informative.

Joe Devine pointed out several items including a memo from the Public Service Comm. (PSC) evidencing that both Thomas Gaylord and his wife, Helen were originally on the list of dissenters to the original agreement. In the minutes of a meeting held on January 20, 1999, Attorney Burandt stated that "life timers" do not pay extra for sewer disposal; therefore, they are not included [in the problems currently plaguing the park]. Attorney Carl Peterson of MHC replied that the sewer was already in operation as of that date, and that the park had not been in compliance for the 12 months prior to hook up. He went on to add that "the pass-through is no issue because it is governmentally mandated." It has been since be proven that no governmental mandate had been issued condemning the waste water plant on the Buccaneer premises. Another comment from Attorney Burandt in these minutes refers to "leaving the lifetimers alone, and wanting residents to have no \$462 pass-through fee, and a reduction in monthly rent of \$15. The mavericks are questioning whether, by remarks such as this, are the lifetime lease holders getting special treatment in this quagmire.

Finally, in the same minutes, then-President Jack Colvin remarked that he had a letter in his possession dated 1985 where homeowners were charged a pass-through in the total amount of \$135,000. The mavericks believe that if residents were billed for approximately \$135 each for maintenance and upkeep of either the treatment plant or the maze of underground pipes leading from homes to the treatment plant, then that automatically made them one-share owners of said plant or infrastructure. They are questioning how MHC could contract with NFMU to make obsolete something that the residents owned without their consent.

The dissenting parties explained to residents the financial difference between each resident being individually billed for waste water disposal and what it would cost if MHC acted as a go-between in the issue and become the customer of NFMU, enabling them to offer a bulk disposal rate to residents. In the latter case, it has been estimated that it would cost residents probably under \$1 if they were charged bulk rates if MHC were being billed and passing the costs on to them, as opposed to the \$10.98 flat monthly fee for the same thing on an individual basis. In conclusion, at the end of the Nov 16 hearing discussion, Commissioner Jacobs asked Jennifer Brubaker, counsel for the PSC, whether the decision would issue as final action. Brubaker stated that it would. Commissioner Deason then asked if it would be subject to reconsideration and appeal. Brubaker answered, "Yes." What this represents to residents is the fact that the decision handed down can and will be appealed. According to law, Devine, Ludington and Gill have 15 days from the date they received the official document from the PSC (December 14, 1999). According to Joe Devine, the mavericks are presently preparing their Motion of Reconsideration. And with the information they have amassed coupled with the knowledge of procedures, Round Two of this ongoing saga will soon begin.

"New times a comin"...... by Ron Ludington

With the approach of elections next month and the new executive that will appear, I would just like to take the time to remind those that get elected, that you must not take the Buccaneer Homeowners for granted any longer. In the past few months the BHA Executive has done things without considering the wishes of the full BHA membership. This has caused a big split in the membership as many homeowners feel they are treated like second class citizens; just because they do not reside in the park all the time, and therefore cannot be present for all meetings. They feel they have not been informed of vital matters in which they deserved a say.

A homeowner, is a homeowner, and is not a full-time or part-time resident or anything else. He/she deserves a say in all matters whether here for meetings or not. Past executives have said that they do not have the time to contact each homeowner, or the expense to do so is too great. We should no longer tolerate this approach. The much disputed sewer "settlement agreement" is proof of that very fact. BHA problems that come up from time to time, must be fully explained, fully studied, and fully voted on, by all homeowners.

Those of you who belong to FMO and have read their latest newsletter, will now know we have been correct all along in insisting that the BHA meeting of Aug 26, 1999, in which the settlement agreement surfaced, was not a legal meeting, because the vote on the agreement was illegal. Irrefer to one vote only per household! The legal way to vote according to FS 723 and the FMO's advisors!! Another reason to join FMO?

And while on the subject of the "settlement agreement", let me say this. The PSC made a decision on Dec. 14 to accept the settlement agreement between OPC/NFMU. The illegal settlement agreement!

I, and a lot of other homeowners, was not very pleased to read of the PSC decision and I have sent PSC a

"Motion for Reconsideration", which is allowed for by law. Others did too; while many homeowners sent in letters telling the PSC of their displeasure with the decision; but our own BHA president sent in a letter telling of the directors' pleasure! By Dec. 29 both OPC and NFMU had already replied to our motions. NFMU even went so far as to discredit the people who had written letters insinuating that they had no right to do that.

How did we get into such a mess??

My motion to the PSC lists several valid points which show that the "settlement agreement" was illegal in its entirety, was not supported by a real majority of the BHA Homeowners, was signed by all parties before presentation for a vote, and that the actual vote was not legal in any case. There were also several other issues that I went over in the motion that need more study by PSC. One of the greatest issues that really needs a visit by PSC, is the original developers' agreement between MHC and NFMU!!

If the PSC chooses to ignore the motions, we (yes, there are several of us) are ready for the next step which involves an appeal in First Civil Court of Appeals. In the meantime you should be free of sewer bills.

I trust that many of you are not aware of the fact that our wastewater committee, by their own admission, started down this road towards a settlement agreement way back in August; instead of allowing the full PSC Hearing of September 14/15 to proceed as scheduled. Did the BHA give them this authority?? But for that move towards the agreement, we very well might be in a totally different situation right now.

The Office of Public Counsel had some very convincing expert witnesses ready for that September hearing. Witnesses who were ready to testify against both MHC and NFMU's involvement in the original developers' agreement. Witnesses that showed it was all a scam!! We could have had this whole mess solved long ago; and to our advantage; but certain parties sought to go another route which may eventually have us paying the sewer bills anyway. What a shame that would be.

Has anyone ever figured out just what will happen when we win the Civil Court case (with Burandt) for excessive rent and sewer charges, but then perhaps still have to pay NFMU for sewer service each month because of this settlement agreement? How would we ever backtrack to where MHC pays the sewer costs if the court finds that is the legal way to proceed? I for one do not want another bill coming to my home each month, especially when the court finds someone else may be liable for it.

Please remember that it was not the 3 mavericks, or the Blo Hard, that promoted the settlement agreement you now face. It was your own BHA Executive!! We have fought it from the beginning! We continue to do so even now!! We wanted to go to the full hearing in September with the expert witnesses!

To the lady at home number 313 who no longer wants the Blo Hard delivered (we won't) and who wants to pay for sewers because she says it's in her lease that she has to; I would just say to read the lease even further and see where it refers to Florida Statute 723, which gives you many rights over what your lease appears to say, and also tells how the park owner must go about passing legal sewer costs on to you.

Can homeowners still help our cause? See below. Don't delay, do it as soon as possible!

Call them starting January 3 or 4! Keep trying until you reach them.

On Monday, December 13, the Buccaneer Homeowners Association held their monthly meeting. The recreation hall was full when the meeting began at 7 p.m., people talking to each other in hushed tones.

Association president, Thomas Gaylord, called the meeting to order. Everyone in the hall stood and saluted the flag. Gaylord welcomed everyone to the meeting saying, "Merry Christmas, Bah Humbug, and Happy New Year," apparently hoping for some positive reaction from the audience — however, there was not so much as a chuckle from anyone. There were more important things on these people's minds than a bit of half-baked humor. They were gathered to hear the answers to questions that had been posed to the BHOA regarding the ongoing problem at Buccaneer with regard to the sewer.

Before long, resident Ruth Anne Kaiser was given the floor and she read a letter in which she thanked the Association for all the hard work that was being done for all of the park residents concerning the problem which was of utmost concern to everyone in the recreation hall. Gaylord tried to rapidly attempt to gloss over the subject of the sewer problems which have been plaguing Buccaneer for more than a year.

However, other residents in the recreation hall were not going to let this happen. There were questions they believed needed answers; where did the Association stand concerning allegations by neighbors Joe Devine, Ron Ludington and Don Gill made in both this newspaper and their own publication "The Blow Hard" that Association members had "sold out" in favor of the NFMU proposal.

Gaylord made allegations of his own that the EXAMINER was unfair by not giving him or other members of the Board the opportunity to tell "their side of the story." This reporter approached him at the dais and handed him a business card and told him that the EXAMINER would be more than happy to speak to him at any time of his choosing. He was also told that two messages had been left on his answering machine to call him prior to this, but that he had evidently ignored the request. In front of the audience, Gaylord informed this reporter that he would be very happy to have the opportunity to speak to the EXAMINER.

As the discussion grew more and more heated when Gaylord refused to give clear answers to any questions asked of him (including the ones he was reading from the newsletter published by Devine, Ludington and Gill), tempers grew shorter and shorter. Gaylord finally shouted into the microphone that the meeting was over and began singing America the Beautiful, ending all discussion, but leaving the meeting open as there had been no motion, no second, or vote to curtail it.

As the audience began filing out of the recreation hall, this reporter again approached Gaylord, hoping to set a date and time for an interview. He refused to do this, telling me that I could call him for an appointment, and if there was no answer, to leave a message on his answering machine and turned his back on me and walked away. During a telephone conversation with the BHOA President on Tuesday afternoon, Gaylord told the EXAMINER, "In reading your reports of this event, I find that you have been extremely biased in your reporting. I do not feel that I would get a fair report in your newspaper. Therefore, I do not feel that I have anything to say to you." Mr. Gaylord, the definition of "biased" is one-sided. Since you, as president of the BHOA have refused to speak to us, I agree that our reporting is biased -- we have only had the opportunity to speak to "the dissenters," who have been more than happy to talk to us. The EXAMINER regrets your feelings on this matter. If given the opportunity

to speak to you, we would have been professional and unbiased in reporting "your side of the story." Both the

EXAMINER and this reporter have always made an effort to accurately report anything that is told to us. And we

In past years the FMO NEWS contained a monthly feature called the Q&A column. This column highlighted questions that were of concern to many FMO members. We are delighted to be able to reintroduce this popular feature in this edition of the FMO NEWS.

Each month we will be addressing one or more questions that members have called or written FMO to have answered. Because this is the time of year when many Chapter 723 homeowner associations are holding their annual meeting of members, we'll begin by looking at what constitutes a quorum at a Chapter 723 homeowner association membership meeting.

QUESTION

We are having our annual homeowners association meeting of members in January. Could you clarify what we must do to fulfill the quorum requirements as provided in Florida Statutes Chapter 723?

ANSWER

The Florida Mobile Home Act, Chapter 723, requires that a <u>"MAJORITY OF THE MEMBERS SHALL CONSITUTE A QUORUM."</u> This is a mandatory provision that must be included in a Chapter 723 homeowner association's bylaws and is not optional. If your association's bylaws require a lesser percentage, then they are not in accordance with the Florida Statutes (F.S.).

F. S. 723.075 defines who is a member of a homeowners association as follows:

...Upon such consent by two-thirds of the mobile home owners, all consenting mobile home owners in the park and their successors shall become members of the association...

You will note that the statute refers to mobile home owners. This means that only the bona fide owner of a mobile home located in the park may be a member of the association. In addition each household is entitled to one vote. This means that while you may have co-owners as members of the association, each unit will have one vote and represents one unit in the establishment of a quorum.

F. S. 723.078(2) (b) governs the bylaws of homeowner associations and makes the following requirement:

A majority of the members shall constitute a quorum. Decisions shall be made by a majority of members represented at a meeting at which a quorum is present.

To better understand what the statute means, let's take a look at an example of a homeowners association in Seaside Mobile Home Park. Seaside has 100 homes located on 100 lots in the park. All of the 100 homeowners in the park have consented to be members of the Seaside Mobile Homeowners' Association, Inc. Each home represents one unit for computation of a quorum regardless of how many people reside in that home. The association is planning its annual membership meeting for January 15, 2000.

In order to have a legal meeting where business can be done, a quorum must be established. Because Seaside has one hundred member units, a majority, or at least 51 of the member units must be represented to constitute a quorum according to Chapter 723. If 51 were the total member units attending the meeting, then according to F.S. 723.078(2)(b), a majority of the 51 units, or 26 units, would be required to make decisions.

Let's see what would happen if 60 member units were represented at the meeting. In this case, 51 would still constitute a quorum, but it would require the vote of 31 members to make decisions.

For many associations, the biggest problem is getting enough members out to the meeting to establish a quorum so that business can be conducted. F.S. 723.078(2)(b) also requires that the association bylaws provide for the definition and use of proxy. If the Seaside Association Bylaws provide that a properly completed proxy may be used to establish a quorum, then a quorum could be established by adding the number of the people present at the meeting with the proxies that had been submitted to arrive at the total of 51 required to constitute a quorum.

Proxies may also be used in the election of officers and voting on other association business; however, proxies must be drawn up for that purpose. It is strongly recommended that you consult with your association attorney on the definition and use of proxies by your association. Your attorney can also provide the association with proxy forms to be used.

The FMO understands the difficulty that faces many homeowner associations in meeting the majority requirement and has tried to have the statutory requirement lowered to 30%. The Legislature, however, has kept the majority requirement. Therefore to conduct legal membership meetings, your association's bylaws must comport with Chapter 723.

The attachments to this letter contain a true copy of a proposed settlement agreement and a ballot which could be used to support the said agreement if one desired to do so.

This proposed agreement was delivered to approximately 750 homes in Buccaneer Estates; homes which were occupied at the time of delivery on November 10, 1999. No form of persuasion was used to obtain a vote either for or against the agreement. Homeowners were simply asked to read the agreement at their leisure, and return the ballot to a certain address in Buccaneer Estates, on their own time, if in favor of the agreement. One ballot was allowed per home.

Within a few days over 350 homes had replied with ballots of support, and since that time another 20 ballots have been returned for a total of 371 homes. Since the average home contains 1.7 people, at last count, we conclude that approximately 670 homeowners voted in favor of the agreement.

We can state with certainty that this level of support is at least twice the support shown for the settlement agreement between OPC/NFMU, first proposed to PSC on September 2, 1999; the very item the PSC has ordered to be the accepted agreement in this matter. Those parties supporting it also claim to have the support of the public which has been shown to be approximately 294 votes only. Many of these 294 supporters have also withdrawn their support since that time.

Find attached also a true copy of the returned ballots, listed in numerical order, (which is also the house number in Buccaneer Estates). Each ballot can be traced to a legitimate home, if one should wish to do so for verification.

We ask the PSC to consider this new information in any reconsideration they may be contemplating on this matter.
