Based on the information provided in your memo dated January 14, 2000, staff has calculated the interest on the overcharges due to Sprint's customers. The total refund amount of \$37,130.30 consists of \$35,035.90 in overcharges and \$2,094.40 in interest. This calculation assumes that the overcharges where incurred evenly from February 1, 1999 to September 19, 1999 and that they will be refunded evenly from May 1, 2000 to June 30, 2000. The appropriate interest rate is the average 30-day commercial paper rate for each month. The last available monthly interest rate of 5.58% is used for the future months past December 1999. Attached is a schedule which shows the calculations.
