ORDER APPROVING ADOPTION OF INTERCONNECTION, UNBUNDLING, AND RESALE AGREEMENT AND APPROVED AMENDMENTS

BY THE COMMISSION:

Bv letter dated January 20, 2000, BellSouth (BellSouth) and YourTel Telecom Telecommunications, Inc. Corporation (YourTel) filed a notice of adoption in its entirety of the interconnection, unbundling, and resale agreement and any amendments to this agreement, approved by the Commission as of the issuance of this Order, entered into and between BellSouth and MCImetro Access Transmission Services, Inc., pursuant to 47 U.S.C. §252(i) of the Telecommunications Act of 1996 (the Act). This agreement was approved by the Commission by Order No. PSC-97-0723-FOF-TP, issued on June 19, 1997, and is incorporated by reference herein. A copy of the agreement and the approved amendments may be obtained by contacting our Division of Records and Reporting.

Both the Act and Chapter 364, Florida Statutes, encourage parties to enter into negotiated agreements to bring about local exchange competition as quickly as possible. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(i) requires that a local exchange carrier shall make available any interconnection, service, or network element provided under an agreement approved by the state commission to any other requesting telecommunications carrier upon the same terms and conditions as those provided in the agreement in its entirety. Further, Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

The adoption of this agreement shall be effective on the date of issuance of this Order and will expire on the date specified in the agreement or the approved amendments. This agreement governs relationship between the companies the regarding local interconnection and the exchange of traffic pursuant to 47 U.S.C. Upon review of the proposed adoption, we find that it §251. complies with the Act; thus, we hereby approve it. We note that we hereby approve the adoption of the amendments to the agreement that we have approved as of the issuance of this Order. BellSouth and YourTel are also required to file any subsequent supplements or modifications to this agreement with the Commission for review under the provisions of 47 U.S.C. § 252(e).

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that BellSouth Telecommunications, Inc. and YourTel Telecom Corporation's adoption in its entirety of BellSouth Telecommunications, Inc. and MCImetro Access Transmission Services, Inc.'s interconnection, unbundling, and resale agreement and all amendments to this agreement, approved by this Commission as of the issuance of this Order, and incorporated by reference in this Order, is hereby approved. A copy of the agreement and the approved amendments may be obtained as specified in the body of this Order. It is further

ORDERED that any supplements or modifications to this agreement must be filed with the Commission for review under the provisions of 47 U.S.C. § 252(e). It is further

ORDERED that this docket is hereby closed.
