GTE FLORIDA INCORPORATED'S REQUEST FOR TEMPORARY PROTECTIVE ORDER

Pursuant to Commission Rule 25-22.006(6)(c), GTE Florida Incorporated (GTE) requests a temporary protective order covering confidential documents produced to the Office of Public Counsel (OPC) in this proceeding. GTE produced the documents in response to discovery served by OPC on September 20, 1999. On November 18, 1999, GTE filed a notice of intent to seek confidential classification of all the material produced. On January 13, 2000, OPC filed a notice of intent to use certain documents at the hearing in this matter.
