This is a follow up to your response to Order No. PSC-99-2402-PAA-TC, which was issued on December 8 and imposed a \$500 fine for not providing the Commission with an updated address within 10 days of a change. Although you may have put in a forwarding address with the US Postal Service, you did not notify the Commission of your new address until after this docket was opened.

You mentioned in your letter that you could not afford to pay the \$500 fine. Unfortunately, I cannot recommend to the Commissioners that this docket be closed without a monetary amount being assessed. Therefore, you need to make a settlement offer if you wish to keep your pay telephone certificate active. In other cases dealing with this rule violation, the Commission has accepted a \$100 settlement in lieu of the \$500 fine imposed. The settlement letter needs to include the following:

- Docket number;
- Statement that in the future, you will notify the Commission within 10 days of any change in address, telephone number, or liaison; and
- Make a specific monetary settlement.
