Dear Mrs. Bayo:

Pursuant to section 252(e) of the Telecommunications Act of 1996, BellSouth and IDS Long Distance, Inc. are submitting to the Florida Public Service Commission an amendment to their negotiated agreement for the interconnection of their networks, the unbundling of specific network elements offered by BellSouth and the resale of BellSouth's telecommunications services to IDS Long Distance, Inc. The Commission approved the initial agreement between the companies in Order No. 99-0660-FOF-TP issued April Ø, 1999 in Docket 990148-TP.

Pursuant to section 252(e) of the Act, the Commission is charged with approving or rejecting the negotiated agreement between BellSouth and IDS Long Distance, Inc. within 90 days of its submission. The Act provides that the Commission may only reject such an agreement if it finds that the agreement or any portion of the agreement discriminates against a telecommunications carrier not a party to the agreement or the implementation of the agreement or any portion of the agreement with the public interest, convenience and necessity. Both parties aver that neither of these reasons exist as to the agreement they have negotiated and therefore, are very hopeful that the Commission shall approve their agreement.

Amendment to the Interconnection Agreement By and Between BellSouth Telecommunications, Inc. And IDS Long Distance, Inc. Dated January 27, 1999

This Agreement refers to the Interconnection Agreement ("the Agreement") entered into by IDS Long Distance, Inc. ("IDS Long Distance") and BellSouth Telecommunications, Inc. ("BellSouth") on January 27, 1999. This Amendment ("Amendment") is made by and between IDS Long Distance and BellSouth and shall be deemed effective on the date executed by IDS Long Distance and BellSouth.

NOW THEREFORE, in consideration of the mutual provisions contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, IDS Long Distance and BellSouth (individually, a "Perty" and collectively, the "Parties") hereby covenant and agree as follows:

1. Section 2.1 of the General Terms and Conditions of the Agreement is hereby deleted in its entirety and replaced with the following:

2.1 The term of this Agreement shall be from January 27, 1999, to July 26, 2000, and shall apply to all of BellSouth's service territory as of January 1, 1997, in the states of Alabama, Florida, Georgia, Kentucky, Louisiana, Mississippi, North Carolina, South Carolina, and Tennessee.

2. Attachment 1 of the Agreement, Resale, is hereby deleted in its entirety and replaced with a new Attachment 1, Resale, attached hereto.

3. Section 2.1.1 of Attachment 2 – Access to Unbundled Network Elements is hereby deleted in its entirety and replaced with the following:

2.1.1 All of the negotiated terms and conditions set forth in this Section pertain to the provision of unbundled loops. Rates pertaining to this Section are contained in Attachment 11.

4. Section 3 of Atlachment 2 – Access to Unbundled Network Elements is hereby amended to include the following language as a new paragraph:

All of the negotiated terms and conditions set forth in this Section pertain to the provision of Integrated Digital Loop Carriers. Rates pertaining to this Section are contained in Atlachment 11.

5. Section 4 of Attachment 2 – Access to Unbundled Network Elements is hereby amended to include the following language as a new paragraph:

All of the negotiated terms and conditions set forth in this Section pertain to the provision of Network Interface Device. Rates pertaining to this Section are contained in Attachment 11.

6. Section 5 of Attachment 2 – Access to Unbundled Network Elements is hereby amended to include the following language as a new paragraph:

All of the negotiated terms and coaditions set forth in this Section pettain to the provision of Unbundled Loop Concentration Systems. Rates pertaining to this Section are contained in Attachment 11.

7. Section 6 of Attachment 2 – Access to Unbundled Network Elements is hereby amended to include the following language as a new paragraph:

All of the negotiated terms and conditions set forth in this Section pertain to the provision of Sub-loop Elements. Rates pertaining to this Section are contained in Attachment 11.

8. Section 7 of Attachment 2 – Access to Unbundted Network Elements is hereby deleted in its entirety and replaced with the following:

7. Local Switching

All of the negotiated terms and conditions set forth in this Section pertain to the provision of local switching. Rares pertaining to this Section are contained in Attachment 11.

9. Section 8 of Attachment 2 - Access to Unbundled Network Elements is deleted in its entirety and replaced with the following:

8. <u>Transport</u>

All of the negotiated terms and conditions set forth in this Section pertain to the provision of unbundled transport. Rates pertaining to this Section are contained in Attachment 11.

10 Section 9 of Attachment 2 - Access to Unbundled Network Elements is hereby amended to include the following language as a new paragraph:

All of the negotiated terms and conditions set forth in this Section penain to the provision of tandem switching. Rates pertaining to this Section are contained in Attachment 11.

11. Section 10 and Section 10.1 of Attachment 2 - Access to Unbundled Network Elements are hereby deleted in their entireties and replaced with the following-

10. <u>Operator call processing. Inward Operator Services and Directory Assistance</u> Services

All of the negotiated terms and conditions set forth in this Section pertain to the provision of Operator Call Processing, Inward Operator Services and Directory Assistance Services. Rates pertaining to this Section are contained in Attachment 11.

10.1 <u>Operator Systems</u>

10.1.1 Definition

Operator Systems is the Network Element that provides operator and automated call handling and billing, special services, end user telephone listings and optional call

completion services. The Operator Systems Network Element provides two types of functions: Operator Service functions and Directory Assistance Service functions, each of which are described in detail below.

12. Section 11 of Attachment 2 - Access to Unbundled Network Elements is hereby deleted in its entirety and replaced with the following:

11. <u>Signaling</u>

All of the negotiated terms and conditions set forth in this Section pertain to the provision of signaling. Rates pertaining to this Section are contained in Attachment 11.

BellSouth agrees to offer access to signaling and access to BellSouth's signaling databases subject to compatibility testing and at the rates set forth in Attachment 11. BellSouth may provide mediated access to BellSouth signaling systems and databases. Available signaling elements include signaling links, signal transfer points and service control points. Signaling functionality will be available with both A-link and B-link connectivity.

13. Section 12 of Attachment 2 - Access to Unbundled Network Elements is hereby amended to include the following language as a new paragraph:

All of the negotiated terms and conditions set forth in this Section pertain to the provision of Signaling Transfer Points. Rates pertaining to this Section are contained in Astachment 11.

14. Section 13 of Attachment 2 – Access to Unbundled Network Elements is hereby amended to include the following language as a new paragraph:

All of the negotiated terms and conditions set forth in this Section pertain to the provision of Service Control Points/Databases. Rates pertaining to this Section are contained in Attachment 11,

15. Section 14 of Attachment 2 – Access to Unbundled Network Elements is hereby deleted in its entirety and replaced with the following:

14. Dark Fiber

All of the negotiated terms and conditions set forth in this Section pertain to the provision of Dark Fiber. Rates pertaining to this Section are contained in Attachment 11. The parties agree that Dark Fiber will be used in the provisioning of local service.

16. Section 15 of Attachment 2 – Access to Unbundled Network Elements is hereby amended to include the following language as a new paragraph:

 All of the negotiated terms and conditions set forth in this Section pertain to the provision of SS7 Network Interconnection. Rates pertaining to this Section are contained in Attachment 11. 17. Section 16 of Attachment 2 - Access to Unbundled Network Elements is hereby deleted in its entirety and replaced with the following:

16. Basic 911 and E911

All of the negotiated terms and conditions set forth in this Section pertain to the provision of Basic 911 and E911. Rates pertaining to this Section are contained in Attachment 11

If IDS Long Distance otders unbundled network elements, then IDS Long Distance is also responsible for providing E911 to its end users. BellSouth agrees to offer access to the 911/E911 network pursuant to the following terms and conditions and at the rates set forth in Attachment 11,

18. Section 17 of Attachment 2 – Access to Unbundled Network Elements is hereby deleted in its entirety and replaced with the following:

17. <u>Name (CNAM)</u>

All of the negotiated terms and conditions set forth in this Section pertain to the provision of CNAM. Rates pertaining to this Section are contained in Attachment II.

The agreement for Calling Name (CNAM) with standard pricing is included as part of this agreement in Attachment 13. IDS Long Distance must provide to its account manager a written request with a requested activation date to activate this service. If IDS Long Distance is interested in requesting CNAM with volume and term pricing, IDS Long Distance must contact its account manager to request a separate CNAM volume and term agreement.

19. Attachment 3 - Local Interconnection is hereby amended to include the following language as a new, unnumbered paragraph as the first paragraph of Attachment 3.

All negotiated terms and conditions set forth in this Attachment pertain to the provision of local interconnection. Rates pertaining to local interconnection are contained in Attachment 11,

20. Section 1 of Attachment 5 – Access to Numbers and Number Portability is hereby deleted in its outirety and replaced with the following language:

1. Non-Discriminatory Access to Telephone Numbers

All negotiated rates, terms and conditions set forth in this Attachment pertain to the provisioning of local number portability.

During the term of this Agreement, IDS Long Distance shall contact Lockheed Martin for the assignment of numbering resources. In order to be assigned a Central Office Code, IDS Long Distance will be required to complete the Central Office Code (NXX) Assignment Request and Confirmation Form (Code Request Form) in accordance with Industry Numbering Committee's Central Office Code (NXX) Assignment Guidelines (INC 95-0407-008).

21. Section 1 of Anachment 6 – Ordering and Provisioning is hereby amended to include the following language as a new paragraph:

> All negotiated rates, terms and conditions set forth in this Attachment pertain to ordering and provisioning.

22. Section 1 of Attachment 7 - Billing and Billing Accuracy Certification is hereby amended to include the following language as a new paragraph:

> All negotiated rates, terms and conditions set forth in this Attachment pertain to billing and billing accuracy certification,

23. All of the other provisions of the Agreement shall remain unchanged and in full force and effect

24. Either or both of the Parties is authorized to submit this Amendment to the appropriate State Public Service Commissions or other Regulatory Agencies for approval subject to Section 252 (e) of the Federal Telecommunications Act of 1996.

RESALE

1 Discount Rates

The rates pursuant by which IDS Long Distance is to purchase services from BellSouth for resale shall be at a discount rate off of the retail rate for the telecommunications service. The discount rates shall be as set forth in Exhibit A, attached hereto and incorporated herein by this reference. Such discount shall reflect the costs avoided by BellSouth when selling a service for wholesale purposes.

2 Definition of Terms

- 2.1 CUSTOMER OF RECORD means the entity responsible for placing application for service; requesting additions, rearrangements, maintenance or discontinuance of service; payment in full of charges incurred such as non-recurring, monthly recurring, toll, directory assistance, etc.
- 2.2 DEPOSIT means assurance provided by a customer in the form of eash, surety bond or bank letter of credit to be held by BellSouth.
- 2.3 END USER means the ultimate user of the telecommunications services.
- 2.4 END USER CUSTOMER LOCATION means the physical location of the premises where an end user makes use of the telecommunications services.
- 2.5 NEW SERVICES means functions, features or capabilities that are not currently offered by BellSouth. This includes packaging of existing services or combining a new function, feature or capability with an existing service.
- 2.6 OTHER/COMPETITIVE LOCAL EXCHANGE COMPANY (OLEC/CLEC) means a telephone company certificated by the public service commissions of BellSouth's franchised area to provide local exchange service within BellSouth's franchised area.
- 2.7 RESALE means an activity wherein a certificated CLEC, such as IDS Long Distance subscribes to the telecommunications services of BellSouth and then reoffers those telecommunications services to the public (with or without "adding value").
- 2.8 RESALE SERVICE AREA means the area, as defined in a public service commission approved certificate of operation, within which a CLEC, such as IDS Long Distance, may offer resold local exchange telecommunications service.

3 General Provisions

3.1 iDS Long Distance may resell the tariffed local exchange and toll telecommunications services of BellSouth contained in the General Subscriber Service Tariff and Private Line

Service Tariff subject to the terms, and conditions specifically set forth herein. Notwithstanding the foregoing, the exclusions and limitations on services available for resale will be as set forth in Exhibit B, attached hereto and incorporated herein by this reference.

- 3.2 All of the negotiated rates, terms and conditions set forth in this Attachment pertain to the resale of BellSouth's retail telecommunications services and other services specified in this Attachment. BellSouth shall make available telecommunications services for resale at the rates set forth in Exhibit A to this Agreement and subject to the exclusions and limitations set forth in Exhibit B to this Agreement. BellSouth does not however waive its rights to appeal or otherwise challenge any decision regarding resale that resulted in the discount rates contained in Exhibit A or the exclusions and limitations contained in Exhibit B. BellSouth reserves the right to pursue any and all legal and/or equitable remedies, including appeals of any decisions. If such appeals or challenges result in changes in the discount rates or exclusions and limitations, the parties agree that appropriate modifications to this Agreement will be made promptly to make its terms consistent with the outcome of the appeal.
- 3.3 IDS Long Distance may purchase resale services from BellSouth for their own use in operating their business. The resale discount will apply to those services under the following conditions:
- 3.3.1 IDS Long Distance must resell services to other end users.
- 3.3.2 IDS Long Distance must order services through resale interfaces, i.e., the Local Carrier Service Center (LCSC) and/or appropriate Resale Account Trans pursuant to Section 3 of the General Terms and Conditions.
- 3.3.3 IDS Long Distance cannot be an alternative local exchange telecommunications company for the single purpose of setling to themselves.
- 3.4 The provision of services by BellSouth to IDS Long Distance does not constitute a joint undertaking for the furnishing of any service.
- 3.5 IDS Long Distance will be the customer of record for all services purchased from BellSouth. Except as specified herein, BellSouth will take orders from, bill and expect payment from IDS Long Distance for all services.
- 3.6 IDS Long Distance will be BeltSouth's single point of contact for all services purchased pursuant to this Agreement. BellSouth shall have no contact with the end user except to the extent provided for herein.
- 3.7 BellSouth will continue to bill the end user for any services that the end user specifies it wishes to receive directly from BellSouth.
- 3.8 BeilSouth maintains the right to serve directly any end user within the service area of IDS Long Distance. BellSouth will continue to directly market its own telecommunications

products and services and in doing so may establish independent relationships with enducers of IDS Long Distance.

- 3.9 Neither Party shall interfere with the right of any person or entity to obtain service directly from the other Party.
- 3.10 Current telephone numbers may normally be retained by the end user. However, telephone numbers are the property of BellSouth and are assigned to the service furnished. IDS Long Distance has no property right to the telephone number or any other call number designation associated with services furnished by BellSouth, and no right to the continuance of service through any particular central office. BellSouth reserves the right to change such numbers, or the central office designation associated with such numbers, or both, whenever BellSouth deems it necessary to do so in the conduct of its business.
- 3.11 For the purpose of the resale of BellSouth's telecommunications services by IDS Long Distance, BellSouth will provide IDS Long Distance with an on line access to telephone numbers for reservation on a first come first serve basis. Such reservations of telephone numbers, on a pre-ordering basis shall be for a period of nine (9) days. IDS Long Distance acknowledges that there may be instances where there is a shortage of telephone numbers in a particular Common Language Location Identifier Code (CLLIC) and in such instances BellSouth may request that IDS Long Distance cancel its reservations of numbers. IDS Long Distance shall comply with such request.
- 3.12 Further, upon IDS Long Distance's request, and for the purpose of the resale of BellSouth's telecommunications services by IDS Long Distance, BellSouth will reserve up to 100 telephone numbers per CLLIC, for IDS Long Distance's sole use. Such telephone number reservations shall be valid for ninety (90) days from the reservation date. IDS Long Distance acknowledges that there may be instances where there is a shortage of telephone numbers in a particular CLLIC and in such instances BellSouth shall use its best efforts to reserve for a ninety (90) day period a sufficient quantity of IDS Long Distance's reasonable need in that particular CLLIC.
- 3.13 BellSouth may provide any service or facility for which a charge is not established herein, as long as it is offered on the same terms to IDS Long Distance.
- 3.14 Service is furnished subject to the condition that it will not be used for any unlawful purpose.
- 3.15 Service will be discontinued if any law enforcement agency advises that the service being used is in violation of the law.
- 3.16 BellSouth can refuse service when it has grounds to believe that service will be used in violation of the law.

- 3.17 BellSouth accepts no responsibility to any person for any unlawful act committed by IDS Long Distance or its end users as part of providing service to IDS Long Distance for purposes of resale or otherwise.
- 3.18 BellSouth will cooperate fully with taw enforcement agencies with subpoenas and court orders for assistance with BellSouth's end users. Law enforcement agency subpoenas and court orders regarding end users of IDS Long Distance will be directed to IDS Long Distance. BellSouth will bill IDS Long Distance for implementing any requests by law enforcement agencies regarding IDS Long Distance end users.
- 3.19 The characteristics and methods of operation of any circuits, facilities or equipment provided by any person or entity other than BellSouth shall not:
- 3.19.1 Interfere with or impair service over any facilities of BellSouth, its affiliates, or its connecting and concurring carriers involved in its service;
- 3.19.2 Cause damage to BellSouth's plant;
- 3.19.3 Impair the privacy of any communications; or
- 3.19.4 Create hazards to any BellSouth employees or the public.
- 3.20 IDS Long Distance assumes the responsibility of notifying BellSouth regarding less than standard operations with respect to services provided by IDS Long Distance.
- 3.21 Facilities and/or equipment utilized by BellSouth to provide service to IDS Long Distance remain the property of BellSouth.
- 3.22 White page directory listings will be provided in accordance with regulations set forth in Section A6 of the General Subscriber Services Tariff and will be available for resale.
- 3.23 BellSouth provides electronic access to customer record information. Access is provided through the Local Exchange Navigation System (LENS) and the Telecommunications Access Gateway (TAG). Customer Record Information includes but is not limited to, customer specific information in CRIS and RSAG. In addition, IDS Long Distance shall provide to BellSouth access to customer record information including electronic access where available. Otherwise, IDS Long Distance shall provide paper copies of customer record information within a reasonable period of time upon request by BellSouth. Customer Record Information is equivalent to but not limited to the type of customer specific information contained in CRIS and RSAG. The Parties agree not to view, copy, or otherwise obtain access to the customer record information of any customer without that customer's permission, and further agrees that IDS Long Distance and BellSouth will obtain access to customer record information only in strict compliance with applicable laws, rules, or regulations of the State in which the service is provided.

- 3.24 All costs incurred by BellSouth to develop and implement operational interfaces shall be recovered from Resellers who utilize the services. Charges for use of Operational Support Systems (OSS) shall be as set forth in Exhibit A of this Attachment.
- 3.25 Where available to BellSouth's end users, BellSouth shall provide the following telecommunications services at a discount to allow for voice mail services:
 - Simplified Message Desk Interface Enhanced ("SMDI-E")
 - Simplified Message Desk Interface ("SMDP") Message Waiting Indicator ("MWI") souther dialtone and message waiting light feature capabilities
 - Cail Forward on Busy/Don't Answer ("CF-B/DA")
 - Call Forward on Busy ("CF/B")
 - Call Forward Don't Answer ("CF/DA")

Further. BellSouth messaging services set forth in BellSouth's Messaging Service Information Package shall be made available for resale without the wholesale discount.

- 3.26 BellSouth's inside Wire Maintenance Service Plans may be made available for resele at rates, terms and conditions as set forth by BellSouth and without the wholesale discount.
- 3.27 All costs incurred by BellSouth for providing services requested by IDS Long Distance that are not covered in the BellSouth tariffs shall be recovered from IDS Long Distance if IDS Long Distance utilizes those services.
- 3.28 Recovery of charges associated with implementing Number Portability through monthly charges assessed to end users has been authorized by the FCC. This end user line charge will be billed to Resetters of BellSouth's telecommunications services and will be as filed in FCC No. 1. This charge will not be discounted.

4 BellSouth's Provision of Services to IDS Long Distance

- 4.1 IDS Long Distance agrees that its resale of BellSouth services shall be as follows:
- 4.1.1 The resale of telecommunications services shall be finited to users and uses conforming to the class of service restrictions.
- 4.1.2 Hotel and Hospital PBX services are the only telecommunications services available for resale to Hotel/Motel and Hospital end users, respectively. Similarly, Access Line Service for Customer Provided Coin Telephones is the only local service available for resale to Independent Payphone Provider (IPP) customers. Shared Tenant Service customers can only be sold those local exchange access services available in BellSouth's A23 Shared Tenant Service Tariff in the states of Florida, Georgia, North Carolina and South Carolina, and in A27 in the states of Alabama, Kentucky, Louisiana, Mississippi and Tenaessee.

- 4.1.3 BellSouth reserves the right to periodically audit services purchased by IDS Long Distance to establish authenticity of use. Such audit shall not occur more than once in a calendar year. IDS Long Distance shall make any and all records and data available to BellSouth or BellSouth's auditors on a reasonable basis. BellSouth shall bear the cost of said audit.
- 4.2 Resold services can only be used in the same manner as specified in BellSouth's Tariffs. Resold services are subject to the same terms and conditions as are specified for such services when furnished to an individual end user of BellSouth in the appropriate section of BellSouth's Tariffs. Specific tariff features (e.g. a usage allowance per month), shall not be aggregated across multiple resold services.
- 4.3 IDS Long Distance may resell services only within the specific resale service area as defined in its certificate.
- 4.4 Telephone numbers transmitted via any resold service feature are intended solely for the use of the end user of the feature. Resale of this information is prohibited.

5 Maintenance of Services

- 5.1 IDS Long Distance will adopt and adhere to the standards contained in the applicable CLEC Work Center Operational Understanding Agreement regarding maintenance and installation of service.
- 5.2 Services resold under BellSouth's Tariffs and facilities and equipment provided by BellSouth shall be maintained by BellSouth.
- 5.3 IDS Long Distance or its end users may not rearrange, move, disconnect, remove or attempt to repair any facilities owned by BellSouth, other than by connection or disconnection to any interface means used, except with the written consent of BellSouth.
- 5.4 IDS Long Distance accepts responsibility to notify BellSouth of situations that arise that may result in a service problem.
- 5.5 IDS Long Distance will be BellSouth's single point of contact for all repair calls on behalf of IDS Long Distance's end users. The parties agree to provide one another with toll-free contact numbers for such purposes.
- 5.6 IDS Long Distance will contact the appropriate repair centers in accordance with procedures established by BellSouth.
- 5.7 For all repair requests, IDS Long Distance accepts responsibility for adhering to BellSouth's prescreening guidelines prior to referring the trouble to BellSouth.
- 5.8 BellSouth will bill IDS Long Distance for handling troubles that are found not to be in BellSouth's network pursuant to its standard time and material charges. The standard

time and material charges will be no more than what BellSouth charges to its retail customers for the same services.

5.9 BellSouth reserves the right to contact IDS Long Distance's end users, if decmed necessary, for maintenance purposes.

6 Establishment of Service

- 6.1 After receiving certification as a local exchange company from the appropriate regulatory agency, IDS Long Distance will provide the appropriate BellSouth service center the necessary documentation to enable BellSouth to establish a master account for IDS Long Distance's resold services. Such documentation shall include the Application for Master Account, proof of authority to provide telecommunications services, an Operating Company Number ("OCN") assigned by the National Exchange Carriers Association ("NECA") and a tax exemption certificate, if applicable. When necessary deposit requirements are met, BellSouth will begin taking orders for the resale of service.
- 6.2 Service orders will be in a standard format designated by BellSouth.
- 6.3 When notification is received from IDS Long Distance that a current end user of BellSouth will subscribe to IDS Long Distance's service, standard service order intervals for the appropriate class of service will apply.
- 6.4 BellSouth will not require end user confirmation prior to establishing service for IDS Long Distance's end user customer. IDS Long Distance must, however, be able to demonstrate end user authorization upon request.
- 6.5 IDS Long Distance will be the single point of contact with BellSouth for all subsequent ordering activity resulting in additions or changes to resold services except that BellSouth will accept a request directly from the end user for conversion of the end user's service from IDS Long Distance to BellSouth or will accept a request from another CLEC for conversion of the end user's service from IDS Long Distance to the other LEC. BellSouth will notify IDS Long Distance that such a request has been processed.
- 6.6 If BellSouth determines that an unauthorized change in local service to IDS Long Distance has occurred, BellSouth will reestablish service with the appropriate local service provider and will assess IDS Long Distance as the CLEC initiating the unauthorized change, the unauthorized change charge described in F.C.C. Tariff No. 1, Section 13 or applicable state tariff. Appropriate nonrecurring charges, as set forth in Section A4 of the General Subscriber Service Tariff, will also be assessed to IDS Long Distance. These charges can be adjusted if IDS Long Distance provides satisfactory proof of authorization.
- 6.7 In order to safeguard its interest, BellSouth reserves the right to secure the account with a suitable form of security deposit, unless satisfactory credit has already been established.

- 6.7.1 Such security deposit shall take the form of an irrevocable Letter of Credit or other forms of security acceptable to BellSouth. Any such security deposit may be held during the continuance of the service as security for the payment of any and all amounts accruing for the service.
- 6.7.2 If a security deposit is required, such security deposit shall be made prior to the inauguration of service.
- 6.7.3 Such security deposit may not exceed two months' estimated billing.
- 6.7.4 The fact that a security deposit has been made in no way relieves IDS Long Distance from complying with BellSouth's regulations as to advance payments and the prompt payment of bills on presentation nor does it constitute a waiver or modification of the regular practices of BellSouth providing for the discontinuance of service for nonpayment of any sums due BellSouth.
- 6.7.5 BellSouth reserves the right to increase the security deposit requirements when, in its sole judgment, circumstances so warrant and/or gross monthly billing has increased beyond the level initially used to determine the security deposit.
- 6.7.6 In the event that 1DS Long Distance defaults on its account, service to IDS Long Distance will be terminated and any security deposits held will be applied to its account.
- 6.7.7 Interest on a security deposit shall accrue and be paid in accordance with the terms in the appropriate BellSouth tariff.

7 Payment And Billing Arrangements

- 7.1 Prior to submitting orders to BellSouth for local service, a master account must be established for IDS Long Distance. IDS Long Distance is required to provide the following before a master account is established: proof of PSC/PUC certification, the Application for Master Account, an Operating Company Number ("OCN") assigned by the National Exchange Carriers Association ("NECA") and a tax exemption certificate, if applicable.
- 7.2 BellSouth shall bill IDS Long Distance on a current basis all applicable charges and credits.
- 7.3 Payment of all charges will be the responsibility of IDS Long Distance. IDS Long Distance shall make payment to BellSouth for all services billed. BellSouth is not responsible for payments not received by IDS Long Distance from IDS Long Distance's end user. BellSouth will not become involved in billing disputes that may arise between IDS Long Distance and its end user. Payments made to BellSouth as payment on account will be credited to an accounts receivable master account and not to an end user's account.

- 7.4 BellSouth will render bills each month on established bill days for each of IDS Long Distance's accounts.
- 7.5 BellSouth will bill IDS Long Distance in advance charges for all services to be provided during the ensuing billing period except charges associated with service usage, which will be billed in arrears. Charges will be calculated on an individual end user account level, including, if applicable, any charge for usage or usage allowances. BellSouth will also bill IDS Long Distance, and IDS Long Distance will be responsible for and remit to BellSouth, all charges applicable to resold services including but not limited to 911 and E911 charges, telecommunications relay charges (TRS), and franchise fees.
- 7.6 The payment will be due by the next bill date (i.e., same date in the following month as the bill date) and is payable in immediately available funds. Payment is considered to have been made when received by BellSouth.
- 7.6.1 If the payment due date falls on a Sunday or on a Holiday which is observed on a Monday, the payment due date shall be the first non-Holiday day following such Sunday or Holiday. If the payment due date falls on a Saturday or on a Holiday which is observed on Tuesday, Wednesday, Thursday, or Friday, the payment due date shall be the last non-Holiday day preceding such Saturday or Holiday. If payment is not received by the payment due date, a late payment penalty, as set forth in section 7.8 following, shall apply.
- 7.6.2 If IDS Long Distance requests multiple billing media or additional copies of bills, BellSouth will provide these at an appropriate charge to IDS Long Distance.
- 7.6.3 Billing Disputes
- 7.6.3.1 Each Party agrees to notify the other Party upon the discovery of a billing dispute. In the event of a billing dispute, the Parties will endeavor to resolve the dispute within sixty (60) calendar days of the Bill Date on which such disputed charges appear. Resolution of the dispute is expected to occur at the first level of management resulting in a recommendation for settlement of the dispute and closure of a specific billing period. If the issues are not resolved within the allotted time frame, the following resolution procedure will begin:
- 7.6.3.2 If the dispute is not resolved within sixty (60) days of the Bill Date, the dispute will be escalated to the second level of management for each of the respective Parties for resolution. If the dispute is not resolved within ninety (90) days of the Bill Date, the dispute will be escalated to the third level of management for each of the respective Parties for resolution
- 7.6.3.3 If the dispute is not resolved within one hundred and twenty (120) days of the Bill Date,
 the dispute will be escalated to the fourth level of management for each of the respective Parties for resolution.

- 7.6.3.4 If a Party disputes a charge and does not pay such charge by the payment due date, such charges shall be subject to late payment charges as set forth in the Late Payment Charges provision of this Attachment. If a Party disputes charges and the dispute is resolved in favor of such Party, the other Party shall credit the bill of the disputing Party for the amount of the disputed charges along with any late payment charges assessed no later than the second Bill Date after the resolution of the dispute. Accordingly, if a Party disputes charges and the dispute is resolved in favor of the other Party the amount of the dispute is resolved in favor of the other Party the amount of the dispute is resolved in favor of the other Party, the dispute is resolved in favor of the other Party, the dispute payment charges and the dispute is resolved in favor of the other Party, the disputing Party shall pay the other Party the amount of the dispute charges and any associated late payment charges assessed no later than the second bill payment due date after the resolution of the dispute. BellSouth shall only assess interest on previously assessed late payment charges in a state where it has authority pursuant to its tariffs.
- 7.7 Upon proof of tax exempt certification from IDS Long Distance, the total amount billed to IDS Long Distance will not include any taxes due from the end user to reflect the tax exempt certification and local tax laws. IDS Long Distance will be solely responsible for the computation, tracking, reporting, and payment of taxes applicable to IDS Long Distance's end user.
- 7.8 If any portion of the payment is received by BellSouth after the payment due date as set forth preceding, or if any portion of the payment is received by BellSouth in funds that are not immediately available to BellSouth, then a late payment penalty shall be due to BellSouth. The late payment penalty shall be the portion of the payment not received by the payment due date times a late factor and will be applied on a per bill basis. The late factor shall be as set forth in Section A2 of the General Subscriber Services Tariff and Section B2 of the Private Line Service Tariff. IDS Long Distance will be charged a fee for all returned checks as set forth in Section to A2 of the General Subscriber Services Tariff or in applicable state law.
- 7.9 Any switched access charges associated with interexchange carrier access to the resold local exchange lines will be billed by, and due to, BellSouth. No additional charges are to be assessed to IDS Long Distance
- 7.10 BellSouth will not perform billing and collection services for IDS Long Distance as a result of the execution of this Agreement. All requests for billing services should be referred to the appropriate entity or operational group within BellSouth.
- 7.11 Pursuant to 47 CFR Section 51.617, BellSouth will bill IDS Long Distance end user common line charges identical to the end user common line charges BellSouth bills its end users.
- 7.12 In general, BellSouth will not become involved in disputes between IDS Long Distance and IDS Long Distance's end user customers over resold services. If a dispute does arise that cannot be settled without the involvement of BellSouth, IDS Long Distance shall contact the designated Service Center for resolution. BellSouth will make every effort to assist in the resolution of the dispute and will work with IDS Long Distance to resolve the matter in as timely a manner as possible. IDS Long Distance may be required to submit documentation to substantiate the claim.

8 Discontinuance of Service

- 8.1 The procedures for discontinuing service to an end user are as follows:
- 8.1.1 Where possible, BellSouth will deny service to IDS Long Distance's end user on behalf of, and at the request of, IDS Long Distance. Upon restoration of the end user's service, restoral charges will apply and will be the responsibility of IDS Long Distance.
- 8.1.2 At the request of IDS Long Distance, BellSouth will disconnect a IDS Long Distance and user customer.
- \$.1.3 All requests by IDS Long Distance for denial or disconnection of an end user for nonpayment must be in writing.
- 8.1.4 IDS Long Distance will be made solely responsible for notifying the end user of the proposed disconnection of the service.
- 8.1.5 BellSouth will continue to process calls made to the Annoyance Call Center and will advise IDS Long Distance when it is determined that annoyance calls are originated from one of their end user's locations. BellSouth shall be indemnified, defended and held harmless by IDS Long Distance and/or the end user against any claim, loss or damage arising from providing this information to (DS Long Distance. It is the responsibility of IDS Long Distance to take the corrective action necessary with its end users who make annoying calls. Failure to do so will result in BellSouth's disconnecting the end user's service.
- 8.1.6 BellSouth may disconnect and reuse facilities when the facility is in a denied state and BellSouth has received an order to establish new service or transfer of service from an end user or an end user's CLEC at the same address served by the denied facility.
- 8.2 The procedures for discontinuing service to IDS Long Distance are as follows:
- 8.2.1 BellSouth reserves the right to suspend or terminate service for nonpayment or in the event of prohibited, unlawful or improper use of the facilities or service, abuse of the facilities, or any other violation or noncompliance by IDS Long Distance of the rules and regulations of BellSouth's Tariffs.
- 8.2.2 If payment of account is not received by the bill day in the month after the original bill day, BellSouth may provide written notice to IDS Long Distance, that additional applications for service will be refused and that any pending orders for service will not be completed if payment is not received by the fifteenth day following the date of the notice. In addition BellSouth may, at the same time, give thirty days notice to the person designated by IDS Long Distance to receive notices of noncompliance, and discontinue the provision of existing services to IDS Long Distance at any time thereafter.
- 8.2.3 In the case of such discontinuance, all billed charges, as well as applicable termination charges, shall become due.

- 8.2.4 If BellSouth does not discontinue the provision of the services involved on the date specified in the thirty days notice and IDS Long Distance's noncompliance continues, nothing contained herein shall preclude BellSouth's right to discontinue the provision of the services to IDS Long Distance without further notice.
- 8.2.5 If payment is not received or arrangements made for payment by the date given in the written notification, IDS Long Distance's services will be discontinued. Upon discontinuance of service on a IDS Long Distance's account, service to IDS Long Distance's end users will be denied. BeliSouth will also reestablish service at the request of the end user or IDS Long Distance upon payment of the appropriate connection fee and subject to BellSouth's normal application procedures. IDS Long Distance is solely responsible for notifying the end user of the proposed disconnection of the service.
- 8.2.6 If within fifteen days after an end user's service has been denied no contact has been made in reference to restoring service, the end user's service will be disconnected.

9 Line Information Database (LIDB)

- 9.1 BellSouth will store in its Line Information Database (LIDB) records relating to service only in the BellSouth region. The LIDB Storage Agreement is included in this Attachment as Exhibit C.
- 9.2 BellSouth will provide LIDB Storage upon written request to IDS Long Distance Account Manager stating requested activation date.

10 RAO Hosting

- 10.1 The RAO Hosting Agreement is included in this Attachment as Exhibit D. Rates for BellSouth's Centralized Message Distribution System (CMDS) are as set forth in Exhibit H of this Attachment.
- 10.2 BellSouth will provide RAO Hosting upon written request to its Account Manager stating requested activation date.

11 Optional Daily Usage File (ODUF)

- 11.1 The Optional Daily Usage File (ODUF) Agreement with terms and conditions is included in this Attachment as Exhibit E. Rates for ODUF are as set forth in Exhibit H of this Attachment.
- 11.2 BellSouth will provide Optional Daily Usage File (ODLF) service upon written request to its Account Manager stating requested activation date.

12 Enhanced Optional Daily Usage File (EODUF)

- 12.1 The Enhanced Optional Daily Usage File (EODUF) service Agreement with terms and conditions is included in this Attachment as Exhibit F. Rates for EODUF are as set forth in Exhibit H of this Attachment.
- 12.2 BellSouth will provide Enhanced Optional Daily Usage File (EODUF) service upon written request to its Account Manager stating requested activation date.

13 Calling Name Delivery (CNAM) Database Service

- 13.1 Calling Name Delivery (CNAM) Database Service Agreement is included in this Attachment as Exhibit G. Rates for CNAM are as set forth in Exhibit H of this Attachment.
- 13.2 BellSouth will provide Calling Name Delivery (CNAM) Database service upon written request to its Account Manager stating requested activation date.

IDS Long Distance will incur an OSS charge for an accepted LSR that is later canceled by IDS Long Distance.

Note: Supplements or clarifications to a previously billed LSR will not incur another OSS charge.

Threshold Billing Plan

The Parties agree that IDS Long Distance will incur the mechanized rate for all LSRs, both mechanized and manual, if the percentage of mechanized LSRs to total LSRs meets or exceeds the threshold percentages shown below:

The threshold plan will be discontinued in 2002.

BeliSouth will track the total LSR volume for each CLEC for each quarter. At the end of that time period, a Percent Electronic LSR calculation will be made for that quarter based on the LSR data tracked in the LCSC. If this percentage exceeds the threshold volume, all of that CLECs' future manual LSRs will be billed at the mechanized LSR rate. To allow time for obtaining and analyzing the data and updating the billing system, this billing change will take place on the first day of the second month following the end of the quarter (e.g. May 1 for 1Q, Aug 1 for 2Q, etc.), There will be no adjustments to the amount billed for previously billed LSRs.

LINE INFORMATION DATA BASE (LIDB) STORAGE AGREEMENT

I. SCOPE

- A. This Agreement sets forth the terms and conditions pursuant to which BellSouth agrees to store in its LIDB certain information at the request of IDS Long Distance and pursuant to which BellSouth, its LIDB customers and IDS Long Distance shall have access to such information. IDS Long Distance understands that BellSouth provides access to information in its LIDB to various telecommunications service providers pursuant to applicable tariffs and agrees that information stored at the request of IDS Long Distance, pursuant to this Agreement, shall be available to those telecommunications service providers. The terms and conditions contained in the attached Addendum(s) are hereby made a part of this Agreement as if fully incorporated herein.
- B. LIDB is accessed for the following purposes:
 - 1. Billed Number Screening
 - 2. Calling Card Validation
 - 3. Fraud Control
- C. BellSouth will provide seven days per week, 24-hours per day, fraud monitoring on Calling Cards, bill-to-third and collect cails made to numbers in BellSouth's LIDB, provided that such information is included in the LIDB query. BellSouth will establish fraud alert thresholds and will notify IDS Long Distance of fraud alerts so that IDS Long Distance may take action it deems appropriate. IDS Long Distance understands and agrees BellSouth will administer all data stored in the LIDB, including the data provided by IDS Long Distance pursuant to this Agreement, in the same manner as BellSouth's data for BellSouth's end user customers. BellSouth shall not be responsible to IDS Long Distance for any lost revenue which may result from BellSouth's administration of the LIDB pursuant to its established practices and procedures as they exist and as they may be changed by BellSouth in its sole discretion from time to time.

IDS Long Distance understands that BellSouth currently has in effect numerous billing and collection agreements with various interexchange carriers and billing clearing houses. IDS Long Distance further understands that these billing and collection customers of BellSouth query BellSouth's LIDB to determine whether to accept various billing options from end users. Additionally, IDS Long Distance understands that presently BellSouth has no method to differentiate between BellSouth's own billing and line data in the LIDB and such data which it includes in the LIDB on IDS Long Distance's behalf pursuant to this Agreement. Therefore, until such time as BellSouth can and does implement in its LIDB and its supporting systems the means to differentiate IDS Long Distance's data from BellSouth's data and the Parties to this Agreement execute appropriate amendments hereto, the following terms and conditions shall apply:

- (a) IDS Long Distance agrees that it will accept responsibility for telecommunications services billed by BellSouth for its billing and collection customers for IDS Long Distance's end user accounts which are resident in LIDB pursuant to this Agreement. IDS Long Distance authorizes BellSouth to place such charges on IDS Long Distance's bill from BellSouth and agrees that it shall pay all such charges. Charges for which IDS Long Distance hereby takes responsibility include, but are not limited to, collect and third number calls.
- (b) Charges for such services shall appear on a separate BellSouth bill page identified with the name of the entity for which BellSouth is billing the charge.
- (c) IDS Long Distance shall have the responsibility to render a billing statement to its end users for these charges, but IDS Long Distance's obligation to pay BellSouth for the charges billed shall be independent of whether IDS Long Distance is able or not to collect from IDS Long Distance's end users.
- (d) BellSouth shall not become involved in any disputes between IDS Long Distance and the entities for which BeilSouth performs billing and collection. BellSouth will not issue adjustments for charges billed on behalf of an entity to IDS Long Distance. It shall be the responsibility of IDS Long Distance and the other entity to negotiate and arrange for any appropriate adjustments.

II. TERM

This Agreement will be effective as of ______, and will continue in effect for one year, and thereafter may be continued until terminated by either Party upon thirty (30) days written notice to the other Party.

III. FEES FOR SERVICE AND TAXES

- A. IOS Long Distance will not be charged a fee for storage services provided by BellSouth to IDS Long Distance, as described in Section I of this Agreement.
- B. Sales, use and all other taxes (excluding taxes on BellSouth's income) determined by BellSouth or any taxing anthority to be due to any federal, state or local taxing jurisdiction with respect to the provision of the service set forth herein will be paid by IDS Long Distance. IDS Long Distance shall have the right to have BellSouth contest with the imposing jurisdiction, at IDS Long Distance's expense, any such taxes that IDS Long Distance deems are improperly levied.

IV. INDEMNIFICATION

To the extent not prohibited by law, each Party will indemnify the other and hold the other harmless against any loss, cost, claim, injury, or liability relating to or arising out of negligence or willful misconduct by the indemnifying Party or its agents or contractors in connection with the indemnifying Party's provision of services, provided, however, that any indemnity for any loss, cost, claim, injury or liability arising out of or relating to

errors or omissions in the provision of services under this Agreement shall be limited as otherwise specified in this Agreement. The indemnifying Party under this Section agrees to defend any suit brought against the other Party for any such loss, cost, claim, injury or liability. The indemnified Party agrees to notify the other Party promptly, in writing, of any written claims, lawsnits, or demands for which the other Party is responsible under this Section and to cooperate in every reasonable way to facilitate defense or settlement of claims. The indemnifying Party shall not be liable under this Section for settlement by the indemnified Party of any claim, lawsuit, or demand unless the defense of the claim, lawsuit, or demand has been tendered to it in writing and the indemnifying Party has unreasonably failed to assume such defense.

V. LIMITATION OF LIABILITY

Neither Party shall be liable to the other Party for any lost profits or revenues or for any indirect, incidental or consequential damages incurred by the other Party arising from this Agreement or the services performed or not performed hereunder, regardless of the cause of such loss or damage.

VI. MISCELLANEOUS

- A. It is understood and agreed to by the Parties that BellSouth may provide similar services to other companies.
- B. All terms, conditions and operations under this Agreement shall be performed in accordance with, and subject to, all applicable local, state or federal legal and regulatory tariffs, rulings, and other requirements of the federal courts, the U.S. Department of Justice and state and federal regulatory agencies. Nothing in this Agreement shall be construed to cause either Party to violate any such legal or regulatory requirement and either Party's obligation to perform shall be subject to all such requirements.
- C. IDS Long Distance agrees to submit to BetiSouth all advertising, sales promotion, press releases, and other publicity matters relating to this Agreement wherein BellSouth's corporate or trade names, logos, trademarks or service marks or those of BellSouth's affiliated companies are mentioned or language from which the connection of said names or trademarks therewith may be inferred or implied; and IDS Long Distance further agrees not to publish or use advertising, sales promotions, press releases, or publicity matters without BellSouth's prior written approval.
- D. This Agreement constitutes the entire Agreement between IDS Long Distance and BellSouth which supersedes all prior Agreements or contracts, oral or written representations, statements, negotiations, understandings, proposals and undertakings with respect to the subject matter hereof.
- E. Except as expressly provided in this Agreement, if any part of this Agreement is held or construed to be invalid or unenforceable, the validity of any other Section of this Agreement shall remain in full force and effect to the extent permissible or appropriate in furtherance of the intent of this Agreement.

- F. Neither Party shall be held liable for any delay or failure in performance of any part of this Agreement for any cause beyond its control and without its fault or hegligence, such as acts of God, acts of civil or military authority, government regulations, embargoes, epidemics, war, terrorist acts, riots, insurrections, fires, explosions, earthquakes, nuclear accidents, floods, strikes, power blackouts, volcanic action, other major environmental disturbances, unusually severe weather conditions, inability to secure products or services of other persons or transportation facilities, or acts or omissions of transportation common carriers.
- G. This Agreement shall be deemed to be a contract made under the laws of the State of Georgia, and the construction, interpretation and performance of this Agreement and all transactions hereunder shall be governed by the domestic law of such State.

RESALE ADDENDUM TO LINE INFORMATION DATA BASE (LIDB) STORAGE AGREEMENT

This is a Resale Addendum to the Line Information Data Base Storage Agreement dated _______, 199 ____, between BellSouth Telecommunications, Inc. ("BellSouth"), and iDS Long Distance ("IDS Long Distance"), effective the _____ day of ______

I. GENERAL

This Addendum sets forth the terms and conditions for IDS Long Distance's provision of billing number information to BellSouth for inclusion in BellSouth's LJDB. BellSouth will store in its LIDB the billing number information provided by IDS Long Distance, and BellSouth will provide responses to on-line, call-by-call queries to this information for purposes specified in Section I.B. of the Agreement.

11. DEFINITIONS

- A. Billing number a number used by BellSouth for the purpose of identifying an account liable for charges. This number may be a line or a special billing number.
- B. Line number a ten digit number assigned by BellSouth that identifies a telephone line associated with a resold local exchange service, or with a SPNP arrangement.
- C. Special billing number a ten digit number that identifies a billing account established by BellSouth in connection with a resold local exchange service or with a SPNP arrangement.
- D. Calling Card number a billing number plus PIN number assigned by BellSouth.
- E. PIN number a four digit security code assigned by BellSouth which is added to a billing number to compose a fourteen digit calling card number.
- F. Toll billing exception indicator associated with a billing number to indicate that it is considered invalid for billing of collect calls or third number calls or both, by the IDS Long Distance.
- G. Billed Number Screening refers to the activity of determining whether a toll billing exception indicator is present for a particular billing number.
- H. Calling Card Validation refers to the activity of determining whether a particular calling card number exists as stated or otherwise provided by a caller.

I. Billing number information - information about billing number or Calling Card number as assigned by BellSouth and toll billing exception indicator provided to BellSouth by the IDS Long Distance.

III. RESPONSIBILITIES OF PARTIES

- A. BeliSouth will include billing number information associated with resold exchange lines or SPNP arrangements in its LIDB. The IDS Long Distance will request any toll billing exceptions via the Local Service Request (LSR) form used to order resold exchange lines, or the SPNP service request form used to order SPNP arrangements.
- B. Under normal operating conditions, BellSouth shall include the billing number information in its LIDB upon completion of the service order establishing either the resold local exchange service or the SPNP arrangement, provided that BellSouth shall not be held responsible for any delay or failure in performance to the extent such delay or failure is caused by circumstances or conditions beyond BellSouth's reasonable control. BellSouth will store in its LIDB an unlimited volume of the working telephone numbers associated with either the resold local exchange lines or the SPNP arrangements. For resold local exchange lines or for SPNP arrangements, BellSouth will issue line-based calling cards only in the name of IDS Long Distance's individual end users. In the event that IDS Long Distance wants to include calling card numbers assigned by the IDS Long Distance in the BellSouth LIDB, a separate agreement is required.
- C. BellSouth will provide responses to on-line, call-by-call queries to the stored information for the specific purposes listed in the next paragraph.
- D. BeliSouth is authorized to use the billing number information to perform the following functions for authorized users on an on-line basis:
- 1. Validate a 14 digit Calling Card number where the first 10 digits are a line number or special billing number assigned by BellSouth, and where the last four digits (PIN) are a security code assigned by BellSouth.
- 2. Determine whether the IDS Long Distance has identified the billing number as one which should not be billed for collect or third number calls, or both.

RAO Hosting

- 1. RAO Hosting, Calling Card and Third Number Settlement System (CATS) and Non-Intercompany Settlement System (NICS) services provided to IDS Long Distance by BellSouth will be in accordance with the methods and practices regularly adopted and applied by BellSouth to its own operations during the term of this Agreement, including such revisions as may be made from time to time by BellSouth.
- 2. IDS Long Distance shall furnish all relevant information required by BellSouth for the provision of RAO Hosting, CATS and NICS.
- 3. Applicable compensation amounts will be billed by BellSouth to IDS Long Distance on a monthly basis in arrears. Amounts due from one Party to the other (excluding adjustments) are payable within thirty (30) days of receipt of the billing statement.
- 4. IDS Long Distance must have its own unique RAO code. Requests for establishment of RAO status where BellSouth is the selected Centralized Message Distribution System (CMDS) interfacing host, require written notification from IDS Long Distance to the BellSouth RAO Hosting coordinator at least eight (8) weeks prior to the proposed effective date. The proposed effective date will be mutually agreed upon between the Parties with consideration given to time necessary for the completion of required Telcordia (formerly BellCore) functions. BellSouth will request the assignment of an RAO code from its connecting contractor, currently Telcordia (formerly BellCore), on behalf of IDS Long Distance and will coordinate all associated conversion activities.
- 5. BellSouth will receive messages from IDS Long Distance that are to be processed by BellSouth, another LEC or CLEC in the BellSouth region or a LEC outside the BellSouth region.
- BellSouth will perform invoice sequence checking, standard EMI format editing, and balancing of message data with the EMI trailer record counts on all data received from IDS Long Distance.
- 7. All data received from IDS Long Distance that is to be processed or billed by another LEC or CLEC within the BellSouth region will be distributed to that LEC or CLEC in accordance with the agreement(s) which may be in effect between BellSouth and the involved LEC or CLEC.
- 8. All data received from IDS Long Distance that is to be placed on the CMDS network for distribution outside the BellSouth region will be handled in accordance with the agreement(s) which may be in effect between BellSouth and its connecting contractor (currently Telcordia (formerly BellCore)).

- 9. BellSouth will receive messages from the CMDS network that are destined to be processed by IDS Long Distance and will forward them to IDS Long Distance on a daily basis.
- Transmission of message data between BellSouth and IDS Long Distance will be via CONNECT:Direct.
- 11. All messages and related data exchanged between BellSouth and IDS Long Distance will be formatted in accordance with accepted industry standards for EMI formatted records and packed between appropriate EMI header and trailer records, also in accordance with accepted industry standards.
- IDS Long Distance will ensure that the recorded message detail necessary to recreate files provided to BellSouth will be maintained for back-up purposes for a period of three (3) calendar months beyond the related message dates.
- 13. Should it become necessary for IDS Long Distance to send data to BellSouth more than sixty (60) days past the message date(s), IDS Long Distance will notify BellSouth in advance of the transmission of the data. If there will be impacts outside the BellSouth region, BellSouth will work with its connecting contractor and IDS Long Distance to notify all affected Parties.
- 14. In the event that data to be exchanged between the two Parties should become lost or destroyed, both Parties will work together to determine the source of the problem. Once the cause of the problem has been jointly determined and the responsible Party (BellSouth or IDS Long Distance) identified and agreed to, the company responsible for creating the data (BellSouth or IDS Long Distance) will make every effort to have the affected data restored and retransmitted. If the data cannot be retrieved, the responsible Party will be liable to the other Party for any resulting lost revenue. Lost revenue may be a combination of revenues that could not be billed to the end users and associated access revenues. Both Parties will work together to estimate the revenue amount based upon historical data through a method mutually agreed upon. The resulting estimated revenue loss will be paid by the responsible Party to the other Party within three (3) calendar months of the date of problem resolution, or as mutually agreed upon by the Parties.
- 15. Should an error be detected by the EMI format edits performed by BellSouth on data received from IDS Long Distance, the entire pack containing the affected data will not be processed by BellSouth. BellSouth will notify IDS Long Distance of the error condition. IDS Long Distance will correct the error(s) and will resend the entire pack to BellSouth for processing. In the event that an out-of-sequence condition occurs on subsequent packs, IDS Long Distance will resend these packs to BellSouth after the pack containing the error has been successfully reprocessed by BellSouth.

- 16. In association with message distribution service, BellSouth will provide IDS Long Distance with associated intercompany settlements reports (CATS and NICS) as appropriate.
- 17. In no case shall either Party be liable to the other for any direct or consequential damages incurred as a result of the obligations set out in this agreement.
- 18. <u>RAO Compensation</u>
- 18.1 Rates for message distribution service provided by BellSouth for IDS Long Distance are as set forth in Exhibit A to this Attachment.
- 18.2 Rates for data transmission associated with message distribution service are as set forth in Exhibit A to this Attachment.
- 18.3 Data circuits (private line or dial-up) will be required between BellSouth and IDS Long Distance for the purpose of data transmission. Where a dedicated line is required, IDS Long Distance will be responsible for ordering the circuit, overseeing its installation and coordinating the installation with BellSouth. IDS Long Distance will also be responsible for any charges associated with this line. Equipment required on the BellSouth end to attach the line to the mainframe computer and to transmit successfully ongoing will be negotiated on a case by case basis. Where a dial-up facility is required, dial circuits will be installed in the BellSouth data center by BellSouth and the associated with the use of the dial circuit by IDS Long Distance will be the responsibility of IDS Long Distance. Associated equipment on the BellSouth end, including a modern, will be negotiated on a case by case basis between the Parties.
- 18.4 All equipment, including moderns and software, that is required on the IDS Long Distance end for the purpose of data transmission will be the responsibility of IDS Long Distance.
- 19. Intercompany Settlements Messages
- 19.1 This Section addresses the settlement of revenues associated with traffic originated from or billed by IDS Long Distance as a facilities based provider of local exchange telecommunications services outside the BellSouth region. Only traffic that originates in one Bell operating territory and bills in another Bell operating territory is included. Traffic that originates and bills within the same Bell operating territory will be settled on a local basis between IDS Long Distance and the involved company(ies), unless that company is participating in NICS.
- 19.2 Both traffic that originates outside the BellSouth region by IDS Long Distance and is billed within the BellSouth region, and traffic that originates within the BellSouth region and is billed outside the BellSouth region by IDS Long Distance, is covered by this Version3099:10/29/99

Agreement (CATS). Also covered is traffic that either is originated by or billed by IDS Long Distance, involves a company other than IDS Long Distance, qualifies for inclusion in the CATS settlement, and is not originated or billed within the BellSouth region (NICS).

- 19.3 Once IDS Long Distance is operating within the BellSouth territory, revenues associated with calls originated and billed within the BellSouth region will be settled via Telcordia (formerly BellCore)'s, its successor or assign, NICS system.
- 19.4 BellSouth will receive the monthly NICS reports from Telcordia (formerly BellCore), its successor or assign, on behalf of IDS Long Distance. BellSouth will distribute copies of these reports to IDS Long Distance on a monthly basis.
- 19.5 BeliSouth will receive the monthly Calling Card and Third Number Settlement System (CATS) reports from Teleordia (formerly BellCore), its successor or assign, on behalf of IDS Long Distance. BellSouth will distribute copies of these reports to IDS Long Distance on a monthly basis.
- 19.6 BellSouth will collect the revenue carned by IDS Long Distance from the Bell operating company in whose territory the messages are billed (CATS), less a per message billing and collection fee of five cents (\$0.05), on behalf of IDS Long Distance. BellSouth will remit the revenue billed by IDS Long Distance to the Bell operating company in whose territory the messages originated, less a per message billing and collection fee of five cents (\$0.05), on behalf on IDS Long Distance. These two amounts will be netted together by BellSouth and the resulting charge or credit issued to IDS Long Distance via a monthly Carrier Access Billing System (CABS) miscellaneous bill.
- 19.7 BellSouth will collect the revenue earned by IDS Long Distance within the BellSouth territory from another CLEC also within the BellSouth territory (NICS) where the messages are billed, less a per message billing and collection fee of five cents (\$0.05), on behalf of IDS Long Distance. BellSouth will remit the revenue billed by IDS Long Distance within the BellSouth region to the CLEC also within the BellSouth region, where the messages originated, less a per message billing and collection fee of five cents (\$0.05). These two amounts will be petied together by BellSouth and the resulting charge or credit issued to IDS Long Distance via a monthly Cartier Access Billing System (CABS) miscellaneous bill.

BeilSouth and IDS Long Distance agree that monthly netted amounts of less than fifty dollars (\$50.00) will not be settled.

Optional Daily Usage File

- 1. Lipon written request from IDS Long Distance, BellSouth will provide the Optional Daily Usage File (ODUF) service to IDS Long Distance pursuant to the terms and conditions set forth in this section.
- IDS Long Distance shall furnish all relevant information required by BellSouth for the provision of the Optional Daily Usage File.
- 3. The Optional Daily Usage Feed will contain billable messages that were carried over the BellSouth Network and processed in the BellSouth Billing System, but billed to a 1DS Long Distance customer.

Charges for delivery of the Optional Daily Usage File will appear on IDS Long Distances' monthly bills. The charges are as set forth in Exhibit A to this Attachment.

- 4. The Optional Daily Usage Feed will contain both rated and unrated messages. All messages will be in the standard Alliance for Telecommunications Industry Solutions (ATIS) EMI record format.
- 5. Messages that error in IDS Long Distance's billing system will be the responsibility of IDS Long Distance. If, however, IDS Long Distance should encounter significant volumes of errored messages that prevent processing by IDS Long Distance within its systems, BellSouth will work with the to determine the source of the errors and the appropriate resolution.
- 6. The following specifications shall apply to the Optional Daily Usage Feed.
- 6.1 Usage To Be Transmitted
- 6.1.1 The following messages recorded by BellSouth will be transmitted to IDS Long Distance:
 - Message recording for per use/per activation type services (examples: Three Way Calling, Verify, Interrupt, Call Return, ETC.)
 - Measured biliable Local
 - Directory Assistance messages
 - IntraLATA Toll
 - WATS & 800 Service
 - N11
 - Information Service Provider Messages
 - Operator Services Messages

- Operator Services Message Attempted Calls (UNE only)
- Credit/Cancel Records
- Usage for Voice Mail Message Service
- 6.1.2 Rated Incollects (originated in BellSouth and from other companies) can also be on Optional Daily Usage File. Rated Incollects will be intermingled with BellSouth recorded rated and unrated usage. Rated Incollects will not be packed separately.
- 6.1.3 BellSouth will perform duplicate tecord checks on records processed to Optional Daily Usage File. Any duplicate messages detected will be deleted and not sent to IDS Long Distance.
- 6.1.4 In the event that IDS Long Distance detects a duplicate on Optional Daily Usage File they receive from BellSouth, IDS Long Distance will drop the duplicate message (IDS Long Distance will not return the duplicate to BellSouth).

6.2 **Physical File Characteristics**

- 6.2.1 The Optional Daily Usage File will be distributed to IDS Long Distance via an agreed medium with CONNECT:Direct being the preferred transport method. The Daily Usage Feed will be a variable block format (2476) with an LRECL of 2472. The data on the Daily Usage Feed will be in a non-compacted EMI format (175 byte format plus modules). It will be created on a daily basis (Monday through Friday except holidays). Details such as dataset name and delivery schedule will be addressed during negotiations of the distribution medium. There will be a maximum of one dataset per workday per OCN.
- 6.2.2 Data circuits (private line or dial-up) may be required between BellSouth and IDS Long Distance for the purpose of data transmission. Where a dedicated line is required, IDS Long Distance will be responsible for ordering the circuit, overseeing its installation and coordinating the installation with BellSouth. IDS Long Distance will also be responsible for any charges associated with this line. Equipment required on the BellSouth end to attach the line to the mainframe computer and to transmit successfully ongoing will be negotiated on a case by case basis. Where a dial-up facility is required, dial circuits will be installed in the BellSouth date center by BellSouth and the associated with the use of the dial circuit by IDS Long Distance will be the responsibility of IDS Long. Distance. Associated equipment on the BellSouth end, including a modern, will be negotiated on a case by case basis between the parties. All equipment, including moderns and software, that is required on IDS Long Distance.

6.3 Packing Specifications

- 6.3.1 A pack will contain a minimum of one message record or a maximum of 99,999 message records plus a pack header record and a pack trailer record. One transmission can contain a maximum of 99 packs and a minimum of one pack.
- 6.3.2 The OCN, From RAO, and Invoice Number will control the invoice sequencing. The From RAO will be used to identify to IDS Long Distance which BellSouth RAO that is sending the message. BellSouth and IDS Long Distance will use the invoice sequencing to control data exchange. BellSouth will be notified of sequence failures identified by IDS Long Distance and resend the data as appropriate.

THE DATA WILL BE PACKED USING ATIS EMI RECORDS.

6.4 Pack Rejection

6.4.1 IDS Long Distance will notify BellSouth within one business day of rejected packs (via the mutually agreed medium). Packs could be rejected because of pack sequencing discrepancies or a critical edit failure on the Pack Header or Pack Trailer records (i.e. outof-balance condition on grand totals, invalid data populated). Standard ATIS EMI Error Codes will be used. IDS Long Distance will not be required to return the actual rejected data to BellSouth. Rejected packs will be corrected and retransmitted to IDS Long Distance by BellSouth.

6.5 Control Data

IDS Long Distance will send one confirmation record per pack that is received from BellSouth. This confirmation record will indicate IDS Long Distance received the pack and the acceptance or rejection of the pack. Pack Status Code(s) will be populated using standard ATIS EMI error codes for packs that were rejected by IDS Long Distance for reasons stated in the above section.

6.6 Testing

6.6.1 Upon request from IDS Long Distance, BellSouth shall send test files to IDS Long Distance for the Optional Daily Usage File. The parties agree to review and discuss the file's content and/or format. For testing of usage results, BellSouth shall request that IDS Long Distance set up a production (LIVE) file. The live test may consist of IDS Long Distance's employees making test calls for the types of services IDS Long Distance requests on the Optional Daily Usage File. These test calls are logged by IDS Long Distance, and the logs are provided to BellSouth. These logs will be used to verify the files. Testing will be completed within 30 calendar days from the date on which the initial test file was sent.

- 1. Upon written request from IDS Long Distance, BellSouth will provide the Enhanced Optional Daily Usage File (EODUF) service to IDS Long Distance pursuant to the terms and conditions set forth in this section. EODUF will only be sent to existing ODUF subscribers who request the EODUF option.
- 2. The IDS Long Distance shall furnish all relevant information required by BellSouth for the provision of the Enhanced Optional Daily Usage File.
- 3. The Enhanced Optional Daily Usage File (EODUF) will provide usage data for local calls originating from resold Flat Rate Business and Residential Lines.
- 4. Charges for delivery of the Ephanced Optional Daily Usage File will appear on IDS Long Distances' monthly bills. The charges are as set forth in Exhibit A to this Attachment.
- 5. All messages will be in the standard Alliance for Telecommunications Industry Solutions (ATIS) EMI record format.
- 6. Messages that error in the billing system of IDS Long Distance will be the responsibility of IDS Long Distance. If, however, IDS Long Distance should encounter significant volumes of errored messages that prevent processing by IDS Long Distance within its systems, BellSouth will work with IDS Long Distance to determine the source of the errors and the appropriate resolution.
- 7. The following specifications shall apply to the Optional Daily Usage Feed.
- 7.1 Usage To Be Transmitted
- 7.1.1 The following messages recorded by BellSouth will be transmitted to IDS Long Distance:

- 7.1.2 BeliSouth will perform duplicate record checks on EODUF records processed to Optional Daily Usage File. Any duplicate messages detected will be detected and not sem to IDS Long Distance.
- 7.1.3 In the event that IDS Long Distance detects a duplicate on Enhanced Optional Daily Usage File they receive from BellSouth, IDS Long Distance will drop the duplicate message (IDS Long Distance will not return the duplicate to BellSouth).
- 7.2 Physical File Characteristics
- 7.2.1 The Enhanced Optional Daily Usage Feed will be distributed to IDS Long Distance over their existing Optional Daily Usage File (ODUF) feed. The EODUF messages will be intermingled among IDS Long Distance's Optional Daily Usage File (ODUF) messages. The EODUF will be a variable block format (2476) with an LRECL of 2472. The data on the EODUF will be in a non-compacted EMI format (175 byte formar plus modules). It will be created on a daily basis (Monday through Friday except holidays).
- 7.2.2 Data circuits (private line or dial-up) may be required between BellSouth and IDS Long Distance for the purpose of data transmission. Where a dedicated line is required, IDS Long Distance will be responsible for ordering the circuit, overseeing its installation and coordinating the installation with BellSouth. IDS Long Distance will also be responsible for any charges associated with this line. Equipment required on the BellSouth end to attach the line to the mainframe computer and to transmit successfully ongoing will be negotiated on a case by case basis. Where a dial-up facility is required, dial circuits will be installed in the BellSouth data center by BellSouth and the associated with the use of the dial circuit by IDS Long Distance will be the responsibility of IDS Long Distance. Associated equipment on the BellSouth end, including a modern, will be negotiated on a case by case basis. All equipment, including moderns and software, that is required on IDS Long Distance's end for the purpose of data transmission will be the responsibility of IDS Long Distance.
- 7.3 Packing Specifications
- 7.3.1 A pack will contain a minimum of one message record or a maximum of 99,999 message records plus a pack header record and a pack trailer record. One transmission can contain a maximum of 99 packs and a minimum of one pack.
- 7.3.2 The Operating Company Number (OCN), From Revenue Accounting Office (RAO), and Invoice Number will control the invoice sequencing. The From RAO will be used to identify to IDS Long Distance which BellSouth RAO that is sending the message. BellSouth and IDS Long Distance will use the invoice sequencing to control data exchange. BellSouth will be notified of sequence failures identified by IDS Long Distance and resend the data as appropriate.

CALLING NAME DELIVERY (CNAM) DATABASE SERVICES

1. DEFINITIONS

For the purpose of this Attachment, the following terms shall be defined as:

CALLING NAME DELIVERY DATABASE SERVICE (CNAM) - The ability to associate a name with the calling party number, allowing the end user subscriber (to which a call is being terminated) to view the calling party's name before the call is answered. This service also provides IDS Long Distance the opportunity to load and store its subscriber names in the BellSouth CNAM SCPs.

CALLING PARTY NUMBER (CPN) - The number of the calling party that is delivered to the terminating switch using common channel signaling system 7 (CCS7) technology, and that is contained in the Initial Address Message (IAM) portion of the CCS7 call setup.

COMMON CHANNEL SIGNALING SYSTEM 7 (CCS7) - A network signaling

technology in which all signaling information between two or more nodes is transmitted over high-speed data links, rather than over voice circuits.

SERVICE CONTROL POINTs (SCPs) - The real-time data base systems that contain the names to be provided in response to queries received from CNAM SSPs.

SERVICE MANAGEMENT SYSTEM (SMS) - The main operations support system of CNAM DATABASE SERVICE. CNAM records are loaded into the SMS, which in turn downloads into the CNAM SCP.

SERVICE SWITCHING POINTs (SSPs) - Features of computerized switches in the telephone network that determine that a terminating line has subscribed to CNAM service, and then communicate with CNAM SCPs in order to provide the name associated with the calling party number.

SUBSYSTEM NUMBER (SSN) - The address used in the Signaling Connection Control Part (SCCP) layer of the SS7 protocol to designate an application at an end signaling point. A SSN for CNAM at the end office designates the CNAM application within the end office. BellSouth uses the CNAM SSN of 232.

2. ATTACHMENT

2.1 This Attachment contains the terms and conditions where BollSouth will provide to IDS Long Distance access to the BellSouth CNAM SCP for query or record storage purposes.

IDS Long Distance shall submit to BeliSouth a notice of its intent to access and utilize BellSouth CNAM Database Services pursuant to the terms and conditions of this Attachment. Said notice shall be in writing, no less than 60 days prior to IDS Long Distance's access to BellSouth's CNAM Database Services and shall be addressed to IDS Long Distance's Account Manager.

3. PHYSICAL CONNECTION AND COMPENSATION

3.1 BellSouth's provision of CNAM Database Services to IDS Long Distance requires interconnection from IDS Long Distance to BellSouth CNAM Service Control Points

- 3.2 In order to formulate a CNAM query to be sent to the BellSouth CNAM SCP, IDS Long Distanceshall provide its own CNAM SSP. IDS Long Distance's CNAM SSPs must be compliant with TR-NWT-001188, "CLASS Calling Name Delivery Generic Requirements".
- 3.3 If IDS Long Distance elects to access the BellSouth CNAM SCP via a third party CCS7 transport provider, the third party CCS7 provider shall interconnect with the BellSouth CCS7 network according to BellSouth's Common Channel Signaling Interconnection Guidelines and Telcordia (formerly BellCore)'s CCS Network Interface Specification document, TR-TSV-000905. In addition, the third party provider shall establish CCS7 interconnection at the BellSouth Local Signal Transfer Points (LSTPs) serving the BellSouth CNAM SCPs that IDS Long Distance desires to query.
- 3.4 Out-Of-Region Customers. If the customer queries the BellSouth CNAM SCP via a third party national SS7 transport provider, the third party SS7 provider shall interconnect with the BellSouth CCS7 network according to BellSouth's Common Channel Signaling Interconnection Guidelines and Bellcore's CCS Network Interface Specification document, TR-TSV-000905. In addition, the third party provider shall establish SS7 ³/₃ interconnection at one or more of the BellSouth Gateway Signal Transfer Points (STPs). The payment of all costs associated with the transport of SS7 signals via a third party will be established by mutual agreement of the parties and writing shall, by this reference become an integral part of this Agreement.

4. CNAM RECORD INITIAL LOAD AND UPDATES

- 4.1 The mechanism to be used by IDS Long Distance for initial CNAM record load and/or updates shall be determined by mutual agreement. The initial load and all updates shall be provided by IDS Long Distance in the BellSouth specified format and shall contain records for every working telephone number that can originate phone calls. It is the responsibility of IDS Long Distance to provide accurate information to BellSouth on a current basis.
- 4.2 Updates to the SMS shall occur no less than once a week, reflect service order activity affecting either name or telephone number, and involve only record additions, deletions , or changes and a service of the se
- 4.3 IDS Linguistance CNAM records provided for storage in the BellSouth CNAM SCP shall be available, on a SCP query basis only, to all parties querying the BellSouth CNAM SCP. Further, CNAM service shall be provided by each party consistent with state and/or federal regulation.
