Dear Ms. Lingo:

It has been helpful to keep in touch with you by phone since you and your colleagues' met with Tropical Isles Residents on December 6, 1999. We were pleased that the Staff's "Preliminary Report" recommended a reduction of \$4.88 per residence per month in the wastewater service rate charged by Florida Water Services (FWS). This was based, as your Report noted, upon recomputation of actual flow data plus using corrected information on potential number of customers and those currently unbilled.

We agree that the lack of such correct data from FWS at the time it requested and received the exorbitant rate increase should not end up as having a negative impact upon the residents of Tropical Isles. Further, you told us at the December meeting, that had PSC been aware of FWS' \$10.00 actual purchase price of the plant and factored it into the rate structure rather than approximately \$450,000 of appraised value in 1988, the rate could have been reduced another \$8.75 per month.

We agree with your Preliminary Report's findings that incomplete & incorrect data were given by FWS. While we won't try to pinpoint FWS' motive other than the profit one, we do feel that we should not be penalized for FWS' deceit or sloppiness.

While Florida law allows major utilities to get a tax break on depreciation when it takes over inefficient, decrepit and/or unprofitable plants, the TI Plant had none of those faults. It was in effect transferred by the Park Owner to SSU/FWS for management convenience. The Park Owner states that he was assured there would be no significant rate increases.

In light of the above, we request that the monthy residential rate for TI customers of FWS be reduced \$4.88 per Staff's Preliminary Report plus the \$8.75 for incomplete information provided on capital investments. This would be a total reduction of \$13.63. Please don't let plant-purchase rumors further delay setting a fair rate.

Further, because FWS has not been forthright in providing information to PSC, we ask that the monthly residential rate reduction be made retroactive to the date of the unfair major increase.

We believe Staff's Preliminary Report shows that an incomplete & incorrect data base has been consistently used by FWS in its rate requests. We request that Staff continue to the obvious end of the road it has begun by including all the incorrect & incomplete data provided by FWS; namely, the original purchase price, and have FWS repay its ill-gotten gains to the retirees of Tropical Isles.
