## **Master Network Interconnection and Resale Agreement**

This Master Network Interconnection and Resale Agreement ("Agreement") between The Ultimate Connection, L.C. d/b/a The Ultimate Connection and Sprint – Florida, Incorporated, a Florida Corporation (Sprint), herein collectively, "the Parties", is entered into and effective this 1st day of February, 2000 for the State of Florida.

NOW THEREFORE, the parties agree as follows:

The Parties agree that the Agreement between the Parties shall consist of the Interconnection and Resale Agreement for the State of Florida entered into by and between Sprint and MCImetro Access Transmission Services, Inc. (MCI) and filed with the Florida Public Service Commission on the 7<sup>th</sup> day of April, 1997 (herein the "MCI Agreement"), amended as follows:

### **TERM:**

This agreement shall be in force until the 7<sup>th</sup> day of April, 2000.

### **RATES:**

All rates provided under this agreement include the subsequent amendments executed by Sprint and MCI.

### **CONDITIONS:**

All services provided under this agreement will be consistent with the Rulings of the 8<sup>th</sup> Circuit Court.
