Staff reviewed your latest submittal to the above referenced docket. The submittal was faxed to Barbara Bailey on February 22, 2000. Staff regards your letter as an indication that you want to pursue a settlement, and an attempt to provide some of the information requested.

If you wish to pursue a settlement, staff must receive the information and documentation requested below by March 27, 2000.

- 1. Reinstate the name J and L Communications as a fictitious name with the Florida Department of State, and provide documentation showing registration has been accomplished;
- 2. Install placards stating the name J and L Communications in all pay phones, and notify the Commission, in writing, when installation of the proper placards is completed;
 - Route all 0- calls to a local exchange company or an alternative local exchange company, and provide documentation showing the proper routing is implemented.
- 4. Provide a list of all pay phones that J and L operates along with the address and phone number of each pay phone; and
- 5. Propose an alternative monetary penalty to the \$3000 fine for service violations and \$10,000 fine for failure to timely respond to Commission inquiries.

From your submittal of February 22, 2000, we determined that you installed an updated placard in one pay phone but we could not determine if they were installed in all pay phones you manage. For this reason, we asked that you provide a list of all pay phones you manage and an affirmative statement that correct placards are installed in all of them. Also, from your February 22 response, we could not determine if the 0- problem was corrected or if the company's name was properly reinstated with the Department of State. Finally, your response did not include a proposal for an alternative monetary penalty.
