CASE BACKGROUND

- **02/07/98** - This company obtained Florida Public Service Commission IXC Certificate No. 5321.
- **12/10/98** - The Division of Administration mailed the regulatory assessment fee (RAF) notice. In accordance with Florida Statute 350.113(4), the Commission "shall provide each regulated company with written notice of the date that payment of the fee is due at least 45 days prior to such date", which would put the due date to February 1, 1999.
- **03/17/99** - The Division of Administration mailed a delinquent letter.

- **10/25/99** - A company representative, Maria Gonzalez, called staff and advised she would pay the past due amount in full and make a settlement offer.
- **11/01/99** - The Commission received the company's payment for the 1998 RAF, including statutory penalty and interest charges.
- **02/01/00** - The Commission received the company's payment for the 1999 RAF. The company reported \$8,700.24 revenues for the period ended 12/31/99.
- **02/21/00** - The Commission received a letter from the company, which proposed to pay a \$100 settlement and advised that steps had been taken to prevent late payments in the future.

Staff believes the following recommendations are appropriate.

DISCUSSION OF ISSUES

ISSUE 1: Should the Commission accept the settlement offer proposed by IAS Film Corporation d/b/a I.A.S. Intercommunication American Systems to resolve the apparent violation of Rule 25-4.0161, Florida Administrative Code, Regulatory Assessment Fees; Telecommunications Companies?

RECOMMENDATION: Yes. The Commission should accept the company's settlement proposal. Any contribution should be received by the Commission within ten business days from the date of the Commission Order and should identify the docket number and company name. The Commission should forward the contribution to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the company fails to pay in accordance with the terms of the Commission Order, the company's Certificate No. 5321 should be canceled administratively. (Isler)

STAFF ANALYSIS: After the docket was opened but prior to staff filing a recommendation, the company paid the past due amount in full, including the 1999 RAF. In addition, the company has since offered a settlement in the amount of \$100 and proposed to pay future RAFs on a timely basis.

Accordingly, staff believes the terms of the settlement agreement as summarized in this recommendation should be accepted. Any contribution should be received by the Commission within ten business days from the date of the Commission Order and should identify the docket number and company name. The Commission should forward the contribution to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the company fails to pay in accordance with the terms of the Commission Order, the company's Certificate No. 5321 should be canceled administratively.
