1. I am an attorney with the law firm of Kelley Drye & Warren LLP. My business address is 1200 19th Street, N.W., Fifth Floor, Washington, D.C. 20036. I am fully familiar with all of the facts and circumstances of this case.

2. I am a member in good standing of the Bar of the District of Columbia. I have been in practice for nine years.

3. I am filing this Affidavit pursuant to the requirements of Rules 28-106.106 and 26-106.107, F.A.C., in connection with my request to be admitted before the Florida Public Service Commission for the sole purpose of this proceeding.

I will have associated with me and personally appearing with me in this
proceeding Patrick K. Wiggins, Esq., and Charles Pellegrini, Esq., of Wiggins & Villacorta,
P.A., who are residents of and are duly and legally admitted to practice in the State of Florida,

In conformity with the requirements of Rule 28-106.106, I have knowledge of (a) jurisdiction; (b) Florida Rules of Civil Procedure relating to discovery in an administrative proceeding; (c) the rules of evidence, including the concept of hearsay in an administrative proceeding; (d) the factual and legal issues involved in the proceeding; and (e) the Standards of Conduct for Qualified Representatives, Rule 18-106.107, F.A.C.

7. In conformity with Rule 28-106.107, F.A.C., I will (1) exercise due diligence to insure that any motion or pleading is filed and argued in good faith; and (2) advise the client to obey the law.

8.
