This letter is our response to your letter dated February 22, 2000. Carib Comm ceased to do business in the State of Florida as of September 1999. We contacted Ms. Biegalski on March 8, 2000 and responded to her letter dated August 2, 1999. A copy of our response and our letter has been included for your review. In that letter, the PSC wanted to know if there were any overcharges to our customers with regards to 0+ / 0- calls. Carib Comm never offered operator services to its customers. Also, in that same letter the PSC wanted to know when we would be revising our tariffs. As we mentioned before, Carib Comm ceased to do all and any type of business as of September 1, 1999, therefore, a revision of the tariffs was not necessary.

In reference to the penalty and interest for the year 1994, we have enclosed a copy of a letter dated September 9, 1994 from Mrs. Valorie Moore in which she mentions the delinguency in this account. Our controller for the company, Ms. Terry Remon, contacted Mrs. Moore on September 16, 1994 and Mrs. Moore told Ms. Remon to WAW

As for penalties and interest for 1995 and 1997, we would like to get the amount due for both returns in order to pay it. Since Carib Comm is no longer in business, we would like to request that both certificates be cancelled as of September 1, 1999. The certificates that need to be cancelled are:

Dear Mr. Mahan:

Staff is in the process of investigating the tariffed rates of the certificated operator service providers in the State of Florida. As a result, it appears that the operator service provider rates on file with the Florida Public Service Commission are in excess of the rate caps as provided in Rule 25-24.630, Florida Administrative Code. For your convenience, I have attached a copy of the Rules Governing Operator Service Providers.

Because its tariffed rates appear to exceed the rate caps applicable to an operator service provider for intrastate 0+ or 0- calls made from a pay telephone or in a call aggregator context, Carib may have overcharged consumers from the time the rate caps became effective on February 1, 1999. Please investigate and provide a written response to the following questions by August 17, 1999:

- 5. In consideration of Rule 25-4.114, Refunds, Florida Administrative Code, what is Carib's proposal to refund consumers should overcharges be determined? 1/1 0
- When will Carib revise its tariff to comply with Rule 25-24.630, Rates and Billing 6.
