ORDER ACKNOWLEDGING WITHDRAWAL OF COMPLAINT

BY THE COMMISSION:

On August 9, 1999, Sprint Communication Company Limited Partnership (Sprint) filed a Petition for arbitration of complaint against BellSouth Telecommunications, Inc. (BellSouth) for failure to comply with interconnection agreement. On August 30, 1999, BellSouth filed its Answer.

On November 17, 1999, Order Number PSC-99-2251-PCO-TP establishing procedure was issued. On December 6, 1999, in response to a joint Motion, Order Number PSC-99-2374-PCO-TP modifying procedure was issued.

On February 18, 2000, Sprint filed a Notice of Voluntary Dismissal, stating it withdraws and voluntarily dismisses, with prejudice, its Complaint against BellSouth. No other party has filed for intervention and we believe that no party would be prejudiced by this act. Therefore, we find it appropriate to acknowledge Sprint Communications Company Limited Partnership's Notice of Voluntary Dismissal.



This filing must be completed within thirty (30) days after the issuance of this order, pursuant to Rule 9.110, Florida Rules of Appellate Procedure. The notice of appeal must be in the form specified in Rule 9.900(a), Florida Rules of Appellate Procedure.
