ORDER APPROVING INTERCONNECTION AGREEMENT

BY THE COMMISSION:

On January 26, 2000, GTE Florida Incorporated (GTEFL) and JATO Operating Two Corp. (JATO) filed a notice of adoption in its entirety of the interconnection agreement entered into and between GTEFL and Rhythm Links, Inc. (f/k/a ACI Corp. d/b/a Accelerated Connections, Inc.), pursuant to 47 U.S.C. §252(i) of the Telecommunications Act of 1996 (the Act). This agreement was approved by this Commission by Order No. PSC-99-1461-FOF-TP, issued July 27, 1999, and is incorporated by reference herein. However, because of the modifications made to the agreement, we have found it more appropriate to handle this agreement as a negotiated agreement rather than as an adoption. A copy of the agreement may be obtained by contacting our Division of Records and Reporting.

Both the Act and Chapter 364, Florida Statutes, encourage parties to enter into negotiated agreements to bring about local exchange competition as quickly as possible. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

This shall be effective on the date of issuance of this Order and will expire on the date specified in the agreement. Further, this agreement governs the relationship between the companies regarding local interconnection and the exchange of traffic pursuant to 47 U.S.C. § 251. Under 47 U.S.C. § 252(a)(1), the agreement shall include a detailed schedule of itemized charges for interconnection and each service or network element included in the agreement.

Upon review of the proposed agreement, we believe that it complies with the Act; thus, we hereby approve it. GTEFL and JATO are also required to file any subsequent supplements or modifications to their agreement with the Commission for review under the provisions of 47 U.S.C. § 252(e).

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the interconnection agreement between GTE Florida Incorporated and JATO Operating Two Corp., is incorporated by reference in this Order, and is hereby approved. A copy of the agreement may be obtained as specified in the body of this Order. It is further

ORDERED that any supplements or modifications to this agreement must be filed with the Commission for review under the provisions of 47 U.S.C. § 252(e). It is further

ORDERED that this Docket shall be closed.
