## ORDER APPROVING AMENDMENTS TO EXISTING RESALE AGREEMENT

BY THE COMMISSION:

On February 4, 2000, BellSouth Telecommunications, Inc. (BellSouth) and OmniCall, Inc. (OmniCall) filed a request for approval of amendments to the existing resale agreement pursuant to 47 U.S.C. §252(e) of the Telecommunications Act of 1996 (the Act). The amendments to the existing agreement is incorporated by reference herein. A copy of the amendments to the existing agreement may be obtained by contacting our Division of Records and Reporting.

Both the Act and Chapter 364, Florida Statutes, encourage parties to enter into negotiated agreements to bring about local exchange competition as quickly as possible. Under the requirements of 47 U.S.C. § 252(e), negotiated agreements must be submitted to the state commission for approval. Section 252(e)(4) requires the state to reject or approve the agreement within 90 days after submission or it shall be deemed approved.

The existing agreement governs the relationship between the companies regarding the resale of tariffed telecommunication services pursuant to 47 U.S.C. § 251. Upon review of the proposed

amendments to the existing agreement, we believe that they comply with the Act; thus, we hereby approve it. The Commission's approval of this agreement should not be construed as a determination that BellSouth has met the requirements of Section 271 of the Act. BellSouth and OmniCall are also required to file any subsequent supplements or modifications to their agreement with the Commission for review under the provisions of 47 U.S.C. § 252(e). We note that one of these amendments is intended to correct the name of one of the companies in the original agreement, Docket No. 991921-TP, from The Other Phone Company, Inc. d/b/a OmniCall, Inc. to Omnicall, Inc.

Based on the foregoing, it is

ORDERED by the Florida Public Service Commission that the amendments to the existing resale agreement between BellSouth Telecommunications, Inc. and OmniCall, Inc., is incorporated by reference in this Order, and is hereby approved. A copy of the amendments to the existing agreement may be obtained as specified in the body of this Order. It is further

ORDERED that any supplements or modifications to this agreement must be filed with the Commission for review under the provisions of 47 U.S.C. § 252(e). It is further

ORDERED that this Docket shall be closed.
