I have received your <u>Delinquent Notice</u> for my 1999 Regulatory Assessment Fee covering January 1, 1999 through December 31, 1999, which was due on January 31, 2000.

I have not been able to pay my fee as my company is no longer in business. As of May 10, 1999 I had to discontinue service from BellSouth for my remaining equipment still installed under contract from businesses. At first I noticed coin revenue not being deposited into the business bank account, then I noticed equipment missing and not accounted for, then no coin revenue was deposited after April 8, 1999 which forced me to have to disconnect with BellSouth as I did not have the earned revenue to pay the bills. Another company ordered interface to run to my remaining equipment still installed in Miami-Dade and Broward Counties. Since then, it was discovered that my address had been changed by someone with The National Payphone Clearinghouse and my mail was opened, the Dial-Around revenue checks endorsement was forged and deposited into the very same bank account as the company operating my equipment that I had under contract to my company.

I do have legal representation by Scott R. Schomber, Esq. with Strauss, Schomber & Williams, P.A. handeling this matter. A trial was set for sometime in June but the other lawyer has since passed away and this may change the court date.

I have no other choice than to accept that you will cancel my certificate for non-payment.
