To Whom It May Concern:

By this notice, Pathnet, Inc. ("Pathnet") hereby notifies the Florida Public Service Commission of (1) a recent internal reorganization and change to its corporate structure; (2) a change of address; and (3) a change of regulatory contact.

Corporate Reorganization. On March 30, 2000, the existing shareholders of Pathnet exchanged their shares of Pathnet's stock for substantially similar shares of stock of Pathnet Telecommunications, Inc. ("Pathnet Telecom"), a Delaware corporation formed on November 1, 1999. In addition, three new investors in the Pathnet business – The Burlington Northern and Santa Fe Railway Company, CSX Transportation, Inc., and Colonial Pipeline Company – contributed to Pathnet Telecom rights-of-way to permit Pathnet Telecom and Pathnet to build a telecommunications network along existing railroad and pipeline corridors. In exchange for contributing the rights-of-way, the new investors received an aggregate of 8,511,607 shares of convertible preferred stock of Pathnet Telecom. Colonial Pipeline Company also contributed or will contribute significant cash in return for additional shares and options to purchase shares of Pathnet Telecom stock and other valuable consideration.

As a result of this transaction, Pathnet became a wholly owned subsidiary of Pathnet Telecom. In addition, Pathnet Telecom received rights-of-way and cash contributions that will better enable Pathnet to provide the telecommunications services it is certified to provide in Florida. Pathnet Telecom will operate as a holding company and will not provide any telecommunications services in Florida. Pathnet will remain the certificated entity and will provide telecommunications services pursuant to its Certificate to provide Alternative Local Exchange Telecommunications.
