

## VCOG, Inc. Resolution No. 2000-04

A Resolution Of VCOG, Inc., Volusia County, Florida, In Addendum To Resolution 99-03, Expressing A Desire That The Florida Public Service Commission Approve A Single Area Code For All Of Volusia County And Designate 386 (FUN) As The New Area Code To Replace 904 And 407 In Volusia County.

Whereas, VCOG (Volusia Council of Governments) was established in January, 1970, as a council of local public officials to develop coordinated plans, programs, and policies of mutual interest; and

Whereas, the Governing Board of VCOG is comprised of representatives from the Cities of Daytona Beach, Daytona Beach Shores, DeBary, DeLand, Deltona, Edgewater, Holly Hill, Lake Helen, New Smyrna Beach, Oak Hill, Orange City, Ormond Beach, Pierson, Ponce Inlet, Port Orange, South Daytona and the County of Volusia; and

Whereas, the explosive growth in telecommunications is rapidly exhausting telephone area code numbers; and

Whereas, it is apparent that the 904 area code, which applies to the greatest majority of telephone subscribers in Volusia County, is soon to run out of numbers and is likely to be replaced; and

Whereas, Volusia County, with its sparkling beaches and endless other leisure activities, is World-famous as a FUN place to live and visit;

Now Therefore, Be It Resolved, by the Governing Board of VCOG, Inc. as follows:

Section 1. The Governing Board of VCOG, Inc. reaffirms its position that there should be a single, new area code for all telecommunications subscribers in Volusia County.

Section 2. The new area code should be designated as 386 (FUN).

Section 3. The VCOG staff is hereby directed to provide a certified copy of this resolution to the Public Service Commission.

Be It Further Resolved, that this Resolution as adopted be attached to the minutes of this meeting held April 24, 2000, in the Conference Room at 1190 Pelican Bay Drive, Daytona Beach, Florida.
