Notice is hereby given this 24 th day of March, 2000, pursuant to Section 367.045 , Florida Statutes, of the application of United Water Florida Inc., to amend its Certificate Nos. 236-W and 179-S to extend its service area located in St. Johns County, Florida, to include the following:

## Parcel A:

A portion of Section 44, Township 5 South, Range 26 East, St. Johns County Florida, and being more particularly described as follows: commence at the intersection of the Southeasterly right of way line of State Road No. 13 (a 100 foot right of way as now established) with the Southerly right of way line of Bombing Range Road (County Road No. 11, also known as Greenbriar Road, as now established); thence South $77^{\circ} 29^{\prime \prime} 3^{\prime \prime}$ East along said Southerly right of way line a distance of $3,752.21$ feet; thence North $34^{\circ} 44^{\prime \prime} 44^{\prime \prime}$ East 66 feet more or less to the Northerly right of way line of Bombing Range Road for a point of beginning; thence North $77^{\circ} 29^{\prime 34}{ }^{\prime \prime}$ West along said Northerly right of way line a distance of $1,641.56$ feet; thence North $13^{\circ} 24^{\prime 2} 9^{\prime \prime}$ East a distance of $1,106.34$ feet; thence South $77^{\circ} 15^{\prime \prime} 01^{\prime \prime}$ East a distance of 2,072.90 feet; thence South $34^{\circ} 44^{\prime} 44^{\prime \prime}$ West a distance of $1,185.62$ feet to the point of beginning.
