

Dear Mr. Bodfish:

The Commission's Division of Administration forwarded a copy of your 1999 regulatory assessment fee return to me for handling with what appears to be a request for voluntary cancellation of your pay telephone certificate. You wrote on the form that all phones had been sold to another company on May 6, 1999.

I cannot recommend voluntary cancellation of a certificate when there is an outstanding balance of regulatory assessment fees (RAFs). You mailed the \$50.00 fee for 1999 on April 13. The payment was due January 31, 2000, therefore, statutory penalty and interest charges are applicable. This means that you owe an additional \$9.00 (\$7.50 penalty and \$1.50 interest).

As information, until the Commission is notified in writing that a company wishes to cancel its certificate, the RAF is due on that certificate if the certificate is active for any day during a calendar year. This means that not only are the 1999 penalty and interest charges past due, but that you are also responsible for the 2000 RAF since the Commission was not notified until April 13, 2000.

I am enclosing a copy of Rule 25-24.514, F.A.C., which explains how to request voluntary cancellation. The company would need to first pay the past due amount in full, and then write the Commission a letter advising when the 2000 RAF fee will be paid.

25-24.514 Cancellation of a Certificate.

- (1) The Commission may cancel a company's certificate for any of the following reasons:
- (a) Violation of the terms and conditions under which the authority was originally granted;
- (b) Violation of Commission rules or orders;
- (c) Violation of Florida Statutes; or,
- (d) Failure to provide service for a period of six (6) months.
- (2) If a certificated company desires to cancel its certificate, it shall request cancellation from the Commission in writing and shall provide the following with its request.
- (a) Statement of intent and date to pay Regulatory Assessment Fee.
- (b) Statement of why the certificate is proposed to be cancelled.
- (3) Cancellation of a certificate shall be ordered subject to the holder providing the information required by subsection (2).
