
Joint Motion for Modification of Staff Testimony Filing Date.

Sprint-Florida, Incorporated (Sprint or the Company) and the Office of the Public Counsel (OPC or Citizens) (hereinafter the Parties) file this Joint Motion requesting that Order No. PSC-00-0869-PCO-TL, issued May 2, 2000, be modified to allow the Staff to file its testimony no sooner than May 31, 2000. In support the Parties state as follows:

Order No. PSC-00-0869-PCO-TL requires that staff file its testimony on May 17, 2000. The Parties believe that at least a two-week extension of the filing date for staff testimony will be in the best interest of resolving the issues in this case. Based on this belief, the Parties urge the Prehearing Officer to grant at least two-week delay in the Staff testimony deadline until no sooner than May 31, 2000.

Wherefore, for the above stated reasons, the Parties jointly request that Order No. PSC-00-0869-PCO-TL be modified accordingly.


