## Joint Motion for Modification of Testimony Filing Dates

GTE Florida Incorporated (GTE or the Company) and the Office of the Public Counsel (OPC or Citizens) (hereinafter the Parties) file this Joint Motion requesting that Order No. PSC-00-0686-PCO-TL issued April 12, 2000, be modified to change the date for the company to file testimony to June 15, 2000, and to change the date for surrebuttal testimony by staff and intervenors to July 14, 2000. In support the Parties state as follows:

Order No. PSC-00-0686-PCO-TL requires the company to file testimony on June 1, 2000, and staff/intervenors to file surrebuttal on June 30, 2000. The Parties believe that a two week extension of these filing dates will be in the best interest of resolving the issues in this case. Based on this belief, the Parties urge the Prehearing Officer to extend the dates for the company to file testimony and for staff/intervenors to file surrebuttal by two weeks.

Wherefore, for the above stated reasons, the Parties jointly request that Order No. PSC-00-0869-PCO-TL be modified accordingly.
