CASE BACKGROUND

- **10/13/98** - This company obtained Florida Public Service Commission ALEC Certificate No. 5706.
- **12/10/98** - The Division of Administration mailed the regulatory assessment fee (RAF) notice. In accordance with Florida Statute 350.113(4), the Commission "shall provide each regulated company with written notice of the date that payment of the fee is due at least 45 days prior to such date", which would put the due date to February 1, 1999.
- **03/17/99** - The Division of Administration mailed a delinquent letter.

- **12/08/99** - The Division of Administration mailed the 1999 RAF notice.
- **02/29/00** - The Division of Administration mailed the delinquent notice for the 1999 RAF.
- **04/28/00** - Order No. PSC-00-0845-PAA-TX was issued, which imposed a \$500 fine or canceled the company's certificate.
- **05/03/00** - Mr. Barry Atkins called staff and advised that the company wished to resolve the docket by paying the past due balance and proposing a settlement.
- **05/10/00** - The Commission received a check for the 1998 and 1999 RAFs, including penalty and interest charges. In addition, the company proposed a settlement.

Staff believes the following recommendations are appropriate.

DISCUSSION OF ISSUES

ISSUE 1: Should the Commission accept the settlement offer proposed by EasyComm Corporation to resolve the apparent violation of Rule 25-4.0161, Florida Administrative Code, Regulatory Assessment Fees; Telecommunications Companies?

RECOMMENDATION: Yes. The Commission should accept the company's settlement proposal. Any contribution should be received by the Commission within ten business days from the date of the Commission Order and should identify the docket number and company name. The Commission should forward the contribution to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the company fails to pay in accordance with the terms of the Commission Order, the company's Certificate No. 5706 should be canceled administratively. (Isler)

STAFF ANALYSIS: After Order No. PSC-00-0845-PAA-TX was issued on April 28, 2000, the company contacted staff and advised it wished to pay the past due amount and propose a settlement to resolve this docket. The company has since paid the 1998 and 1999 RAFs, including penalty and interest charges; offered a settlement in the amount of \$100; and proposed to pay future RAFs on a timely basis.

Accordingly, staff believes the terms of the settlement agreement as summarized in this recommendation should be accepted. Any contribution should be received by the Commission within ten business days from the date of the Commission Order and should identify the docket number and company name. The Commission should forward the contribution to the Office of the Comptroller for deposit in the State General Revenue Fund pursuant to Section 364.285(1), Florida Statutes. If the company fails to pay in accordance with the terms of the Commission Order, the company's Certificate No. 5706 should be canceled administratively.
